	<p>The following is a summary of the investigation. Information was collected from, but not limited to, victims, witnesses, law enforcement officers, CAD Notes, 911 Calls, forensic reports and video sources. The times listed in the report are approximate as the sources may have differing clock times. More specific information will follow in additional narratives in this report.</p> <p>On 11/20/2014, I was assigned as the on-call Homicide/Violent Crimes Unit (VCU) Investigator. At approximately 12:46 a.m. I was contacted by the Consolidated Dispatch Agency and informed that there had been a shooting at Strozier Library and that at least one person was deceased. Almost immediately thereafter I was contacted by Homicide/VCU Sgt. Boccio. He informed me that the shooting was officer involved and that numerous officers were involved. He assigned me to go to the Tallahassee Police Department (TPD) and handle the involved officers responding to that location.</p> <p>Myself and Investigator Scott Cherry responded to TPD to await the involved officers. Other investigators from the Violent Crime Unit responded to the scene. When officers arrived at TPD it was verified that they had "Buddy Officers" with them. The following officers identified themselves as being involved: Officer Oma "Zack" Nations (FSU), Officer Parise Adams (FSU), Officer Daniel Cutchins (FSU), Sgt. Roy "Cliff" Wiley (FSU), and Officer Wayne Staats (TPD).</p> <p>I contacted Officer R. Underwood (Training Unit) and asked that he respond to TPD to conduct a round count and issue new firearms in accordance with Officer Involved Shooting protocol. FSU Officer Jason</p>

Harris (Training Unit) responded to issue FSU officers new firearms.

In accordance with Officer Involved Shooting protocol the officers were not questioned at that time. Their respective PBA Attorneys (Stephanie Webster and Stephen Webster) responded to TPD and met with the officers.

Myself and Inv. Cherry were present while a round count was conducted on each officer (See Inv. Cherry's supplement for a detailed narrative of the round count).

In summary:

Each officer that fired their weapon had a Glock Model 22, .40 caliber pistol with a 15 round magazine in it. FSU Police Officers had "Speer" ammunition and Officer Staats (TPD) had "Winchester" Ammunition.

Officer Nations - The magazine from his pistol had a 15 round capacity and had 9 bullets in it. Additionally, his pistol had a round in the chamber. His other magazines had 15 rounds in them. This indicates that if Officer Nations had a full magazine at the time of the shooting he fired six (6) rounds.

Officer Adams - The magazine from his pistol had a 15 round capacity and had 4 bullets in it. Additionally, his pistol had a round in the chamber. This indicated that if Officer Adams had a full magazine at the time of the shooting he fired eleven (11) rounds.

Officer Cutchins - After the shooting Officer Cutchins conducted a reload. The magazine in his firearm at the time of the shooting was in his magazine pouch and had 3 bullets in it. Additionally, his pistol had a round in the chamber. This indicates that if Officer Cutchins had a full magazine at the time of the shooting he fired twelve (12) rounds.

Sgt. Wiley - The magazine from his pistol had a 15 round capacity and had 13 bullets in it. Additionally, his pistol had a round in the chamber. This indicated that if Sgt. Wiley had a full magazine at the time of the shooting he fired two (2) rounds.

Officer Staats - After the shooting Officer Staats conducted a reload. The magazine in his firearm at the time of the shooting was in his rear pocket and had 11 bullets in it. Additionally, he had a round in the chamber. This indicates that if Officer Staats had a full magazine at the time of the shooting he fired four (4) rounds.

TPD Officer Nick Lowe and FSU Officer Orenthya "O.J." Sloan were witnesses to the incident and in close proximity at the time of the shooting. A round count was conducted of both officers' weapons and all their ammunition was accounted for.

At approximately 3:21 a.m. myself and Inv. Cherry interviewed FSU Officer Sloan in CID Interview Room #1 which was audio/video recorded. Inv. Cherry read Officer Sloan an Oath/Perjury Warning from a pre-printed form and Officer Sloan signed it.

At the time of the initial call he was at the station (FSU Police Department). The dispatch transmissions included that shots had been fired by a black male in all black. A dispatch transmission also indicated that the subject had come out of Strozier and was going toward the Thagard Building. While

responding in his vehicle he was flagged down by who he believed to be a maintenance person in a white Chevy Trailblazer. The subject told Officer Sloan that the subject was running back toward Strozier and that he needed to stop him before he hurt someone. He also told Officer Sloan that the subject was wearing a red sweater. Officer Sloan continued toward Strozier. He got his patrol rifle and headed toward where he saw the rest of his squad.

When he made it to the rest of his squad they were already addressing the gunman and fanned out in what he described as "an arc". He came up behind them but could not get a good shooting position due to the way the officers were spread out. He could see the suspect with a gun in one of his hands and heard other officers giving loud verbal commands for him to drop the gun. He believed that he was standing closest to Sgt. Wiley because he remembered how loud Sgt. Wiley's commands to drop the gun were.

Officer Sloan said that the subject looked at the officers while they were giving commands and it seemed like he wanted the officers to shoot him. Officer Sloan explained that the commands were so loud and the suspect never made an attempt to drop the gun. It appeared that he understood the commands but just chose to ignore them.

The suspect made a motion as if he was going to swing around and officers fired (Demonstrated by Officer Sloan as turning toward where officers were with the gun in his hand). Officer Sloan said he did not fire because the muzzle of his rifle was not clear of other officers.

After the suspect was down Officer Sloan moved in and handcuffed the suspect. He saw Officer Adams conducting a search/patdown. He also remembered Officer Adams checking the suspect for a pulse but did not know if the suspect had one.

Other officers arrived on scene and Sgt. B. Davis (TPD) took control. Officer Sloan gave him information then checked subjects as they came out of the library.

Officer Sloan informed us that he was wearing a body camera at the time of the incident and while searching the library after the shooting he noticed that it was on. He did not remember turning it on and did not know when it came on. It is activated by sliding up a small door in front of the lens and felt it must have come on when something pushed against it. Officer Poppe (Traffic Unit) was at TPD and was able to download the video. It had not been activated until well after the shooting and contained no footage of the shooting.

Officer Sloan had an in-car video. A copy of the video was provided to Forensic Specialist Kornegay on 11/20/2014. I was able to review it at a later time. The video had no sound. It showed Officer Sloan's response to the library in his vehicle. It also showed the encounter with the maintenance person in the white trailblazer. When Officer Sloan arrived at Strozier he ended up parking his vehicle behind a tree facing the library at 12:28 a.m. There is a partial view of the front of Strozier Library but the area where the shooting took place was blocked by a tree branch. Officer Sloan can be seen running from the vehicle toward the Library.

At around 4:14 a.m. myself and Inv. Cherry interviewed Officer Nick Lowe in CID Interview Room #1. The interview was audio/video recorded. Inv. Cherry read him the Oath/Perjury warning from a pre-printed form which he signed. Officer Lowe was at the Tallahassee Fire Department Station 1 when

he heard the call come out of someone with a gunshot wound on FSU Campus at Strozier Library. He responded lights and siren. As he pulled up he saw people running everywhere. When he got to Call Street at Dewey Street he began getting out of his car and heard gun shots. He ran to the Library and when he arrived the shooting was already over.

As part of the investigation I received two videos of Strozier Library obtained by Investigator R. Kerce. One of the videos was titled "Strozier Main Exit" and the other "Strozier Main Entry". I placed the videos into evidence.

While reviewing the videos I noted that after entering the main entry of the library building there was a Security Desk in front of the Western most entry. The desk is where victims (Nathan Scott and Page McPhadden) were sitting. The "Strozier Main Entry" video covered this area.

After entering the library building and to the left of the security desk (while facing it) is the interior entry into the library which is blocked by turnstiles (2 entry and 2 exit with a gate for handicapped access). The "Strozier Main Exit" video covered that area.

While reviewing the video I noted that students had to use swipe cards to enter and exit the library. I spoke to FSU Sgt. Wooten who informed me that swipe card activity through the turnstiles was captured and recorded. On 11/24/2014, he provided me with a record of the swipe card activity. The record included the name of the student, the turnstile the card was swiped (In or Out), and times the card was swiped.

Neither video from Strozier Library was time stamped. However, by using the turnstile swipe card reader I was able to assign approximate times to the video.

A review of the combined videos, CAD Notes, victim statements and 911 calls showed the following approximate chronological account of what took place at Strozier Library (The times are approximate based on the card reader compared to images in the videos, 911 Calls and CAD Notes):

At approximately 12:06 a.m. Myron May entered the library through doors by the coffee shop carrying a pink bag (similar to the size of a laptop computer case) and a book in his left hand. He walked past the welcome desk and toward the turnstiles.

At approximately 12:07 a.m. May approached the two entry turnstiles. He went to the right side entry and attempted to walk through the turnstile by pushing it with the front of his legs but it did not open. He stepped back and looked at it as if trying to figure out how it worked then turned and went back the way he came. At the time he was still carrying the pink bag and book in his left hand.

At 12:09 a.m. victim Farhan Ronny Ahmed left the library through the turnstiles. At 12:20 a.m. victim Elijah Velez left through the turnstiles. According to Ahmed he went to the picnic tables outside the library and was talking to Robert Cohen. According to Elijay Velez he went to the bicycle racks to get his bike.

At approximately 12:21 p.m. victim Jason Derfuss appeared in the video while in the library walking toward the exit turnstiles. He stopped, took his backpack off and set it on the floor. He put what appeared to be book(s) into the backpack. He then picked the backpack up and put it back on while

walking toward the turnstiles. He then exited through the turnstiles at 12:22-12:23 a.m. He then walked out the main library doors across from the security desk. At that time Nathan Scott and Paige McPhadden were sitting behind the security desk.

Almost immediately after Derfuss walked out the door Scott and McPhadden can be seen looking out the front of the library as if something happened. They eventually duck down under the security desk. Scott would later tell me the following:

He initially became aware of the incident when he heard a single shot from outside the library. He thought it was probably a firecracker or kids messing around. He then heard three (3) more shots and looked out the front to see the suspect (May) coming from the area where Farhan Ronny Ahmed was found. As May moved he fired several more shots across toward the dorms (Easterly direction). (This is consistent with shooting at Elijay Velez). That is when Scott and McPhadden hid under the desk.

While Scott was under the desk May came around and shot him. Scott saw him for only a second and May said nothing before or after shooting him. After he was shot he heard a "click". This is consistent with May having attempted to shoot McPhadden.

According to Derfuss he walked out the door and down the stairs in front of the library when he heard a loud pop. He froze and turned around. He saw a male in what he thought was a black hoodie running toward someone else by the picnic tables (Believed to be Farhan Ronny Ahmed). He saw the suspect (May) shoot at someone by the tables two times and noted that there were two people by the tables. After the second shot, the person the suspect was shooting at went down. The suspect looked back in the direction of Derfuss who ran to his vehicle. Derfuss did not get a good look at the suspect.

According to Farhan Ronny Ahmed he was by the picnic tables when he heard a "pop". He looked in the direction of where the sound came from (front of the library) and he saw some smoke rising. He then saw a guy (Myron May) walking around the side of the bushes toward them. He noted that May had a stern face and was carrying a silver colored gun with a black bottom (handle). May then pulled up the gun and shot at him three times. The first shot dropped him and is the one that severed his spine. One of the other shots hit his right upper arm and traveled into his torso coming to rest approximately 4 centimeters from his heart. May never said anything to Ahmed.

Cohen later told investigators that he was with Ahmed when May walked toward them and shot at Ahmed. Ahmed fell to the ground and then May shot at him (Cohen). May then turned around and went back to the library. (Investigators located what appeared to be a bullet hole in Cohen's coat).

Ahmed told Cohen to call the police. Cohen called 911 using his phone then gave it to Ahmed and ran from the area. Ahmed talked to a dispatcher on 911 letting them know he had been shot and asked for help. Information received from the Consolidated Dispatch Agency (CDA) showed that the call was received at 12:24:27 a.m.

Victim, Elijay Velez, was leaving at the time of the incident. While walking to his bicycle he heard a loud boom that sounded like a firecracker. He began walking toward "Bellamy" (Bellamy Building). He saw two kids by tables (presumably Robert Cohen and Farhan Ronny Ahmed).

The suspect (May) shot one of them and he fell. (This is consistent with where Farhan Ronny Ahmed

was found). May then started walking toward him and shot at him. A bullet hit his bike which caused him to fall off of it. May shot again but Velez did not feel anything. He later learned that he had been grazed by a bullet. An inspection of his clothes showed that the bullet went through multiple layers of clothing but left only a scratch on his torso. May then went inside the Library and continued shooting.

The video showed that approximately 20 seconds after Derfuss had walked out of the library (Approximately 12:23 a.m.), May walked in to the library through the door that Derfuss had left from. He walked to the welcome desk and around behind it where Nathan Scott and Paige McPhadden were hiding. May was holding the firearm in his right hand. With a one handed grip he pointed in the direction Nathan Scott was hiding and shot. He then pointed at Paige McPhadden and appeared to attempt to shoot. Scott would later tell officers that May pulled the trigger multiple times after shooting him but the gun failed to fire. After May walked away Scott believed he was reloading or clearing a malfunction because he heard sounds of metal surfaces rubbing against each other.

Around this same time two unknown white males were recorded swiping their cards at the exit turnstiles when one of the subjects quickly reacted to something by covering his head and crouching. He then looked toward the front of the library.

The second subject reacted by turning his head away from the front of the library and rolling his shoulders forward (cringing) as in anticipation of something. He then looked toward the front of the library. Both subjects then fled back into the library. Based on a review of the swipe card logs it appears that this was at 12:23 a.m.

After May shot Scott he walked toward the front doors but turned toward the coffee shop and walked toward it. After May walked toward the coffee shop, Nathan Scott limped from around the desk and into the library. Paige McPhadden followed shortly behind him.

Security Guard Christian Mills came from inside the library through the exit turnstiles and went to the main entry doors of the library. While looking out the doors it appeared he became aware that the shooter was still in the building and only a short distance away from him. He then went back into the library. Mills later told Inv. Able that when he saw May he heard a very distinct sound of "metal on metal" as if he was loading rounds into the gun magazine.

Although not clear on video it appears that while May was at the coffee shop he was reaching into his pockets and doing something with his firearm. Based on the number of bullets fired at this point, and Mills statement, it is likely that he was reloading the magazine to the firearm with bullets from his pocket. (At the time officers searched him he had additional .380 bullets in his pockets).

The video shows a subject walk in through the main library doors and May walked past him and out the door onto the front patio of the library.

A review of 911 Calls obtained from the Consolidated Dispatch Agency (CDA) show that the first 911 call was received at 12:24:09 a.m. The unknown caller reported that someone shot someone in front of Strozier Library on FSU Campus. The dispatcher attempted to transfer the caller to FSU but soon advised that FSU was already receiving calls.

A second 911 call came into the CDA at 12:24:27. The call was from 365.171(12)

FSU CAD Notes began at 12:25 a.m. with initial information of gun shots and the subject running toward Thagard. The notes were quickly updated that the suspect ran back toward Strozier.

As part of the investigation Sgt. Wooten provided not only the FSU CAD Notes but also audio recording of FSU Police Non-emergency recorded phone calls and radio transmission. The files are in WAV. Files and will be referred to by the file name in this report.

A review of the FSU Police Non-emergency recorded phone calls and radio transmissions showed that the calls and radio traffic are not timed stamped. However, the first phone call received was from an unknown female who told the dispatcher that there was a black guy with a gun at Strozier Library. As soon as the dispatcher heard the information she immediately radioed that any available unit be enroute to Strozier Library in reference to a black male armed with a handgun. Another female, believed to be Paige McPhadden, then took the phone from the female and provided further information to include the suspect firing outside the library then coming in and shooting her co-worker. The dispatcher immediately provided this information over the radio to responding units. (Audio_202_221_2_files.wav).

According to FSU CAD Notes it appears officers arrived around 12:27-12:28 a.m. and at 12:28:48 Sgt. Wiley radioed that shots had been fired (Audio242_274_5_files.wav).

VICTIM INTERVIEWS:

Jason Derfuss (Student) - Shot in His Bookbag

At approximately 5:44 a.m. on 11/20/2014, myself and Inv. Cherry interviewed victim Jason Derfuss in CID Interview Room #1. The interview was audio/video recorded. Inv. Cherry read him the Oath/Perjury warning from a pre-printed form which he signed.

Derfuss said that he was at Strozier and checked out a couple of books. When he walked out of the library he went down the steps and heard a gunshot. He froze and turned around. He saw a male in a black hoodie running toward someone else by the picnic tables. He saw the suspect shoot at someone by the tables two times and noted that there were two people by the tables. After the second shot the person the suspect was shooting at went down. The suspect looked back in the direction of Derfuss who ran to his vehicle. He did not get a good look at the suspect.

He initially called his dad then called 911 and went home. Later he took his books out of his backpack and discovered that they were mangled and he had a hole in his backpack. He dumped out the contents and discovered a bullet. He called his dad then 911 again. Officers responded and impounded his backpack, books, and bullet from the backpack. They also got a written statement from him.

About an hour later officers came back to his residence and brought him to TPD. Derfuss said he did not feel the bullet hit his backpack, which he was wearing at the time. The bullet went into his backpack, through a paperback book and into a hardcover book. It lodged in the hardcover book and did not penetrate it. Derfuss demonstrated how he was wearing the backpack at the time. Had he not been wearing the backpack, and had it not been so full, the bullet would have struck him in his back.

Paige McPhadden (Library Employee) - Suspect Attempted to Shoot Her.

On 11/20/2014, around 6:49 a.m. Inv. J. Newhouse interviewed Paige McPhadden at TPD in CID Interview Room #1. The interview was audio/video recorded. She and Nathan Scott ("Nate") were sitting at the security desk inside the entry to the library. They heard a gunshot and when she looked up she saw a figure standing outside. It appeared he was pointing a gun in the direction of the coffee shop. He was back peddling as if he was going to go down the stairs. While he was back peddling he fired more shots. She and Nate hid under the desk.

A couple seconds later she heard a gunshot inside the library that was really close. Instantaneously Nate screamed and said, "No don't". She could smell the gun powder. She never saw the shooter when he came behind the desk. When they thought it was safe they went into the library.

Elijay Velez (Student) - Shot at multiple times and grazed on his torso.

On 11/20/2014, at 3:33 a.m. Inv. Houston and Inv. Couch conducted an audio/video recorded interview with Velez at the FSU Police Department.

A review of the video showed that Velez reported the following: He got to the library around 10:35 p.m. and was leaving at the time of the incident. He walked out of the library and went to the bike racks to get his bike. He heard a loud boom that sounded like a firecracker. He began walking toward "Bellamy" (Bellamy Building) when he saw two kids by tables (presumably Robert Cohen and Farhan Ronny Ahmed).

The suspect shot one of them and he fell. (This is consistent with where Farhan Ahmed was found). Velez did not know if he shot again. The suspect then started walking toward him and shot at him. The bullet hit his bike which caused him to fall off of it. The suspect shot again but Velez did not feel anything.

The suspect went inside the Library and started shooting some more. He then came out and started standing on the stairs. Then he sat down on the benches that were there. People started running out at which time he got his bike and left. Velez described the suspect as being dark skinned and he believed he was wearing a dark colored "hoodie".

Nathan Scott (Library Employee) - Shot in the leg while hiding behind the front desk in the library.

On 12/02/2014, I spoke to Nathan Scott by phone to check on his condition and gather anything he could add to the video. Scott told me that he initially became aware of the incident when he heard a single shot from outside the library. He thought it was probably a firecracker or kids messing around. He then heard three (3) more shots and looked out the front to see the suspect (May) coming from the area where Farhan Ronny Ahmed was found. As May moved he fired several more shots across the walkway in front of the library. (This is consistent with shooting at Elijay Velez). That is when he hid under the desk.

While he was under the desk May came around and shot him (upper leg area). Scott saw him for only a second and May said nothing before or after shooting him. After he was shot he heard a "click". This is consistent with May having attempted to shoot McPhadden. Additionally, on the day of the incident, Scott told Officer Nieves that May pulled the trigger multiple times after he shot him but that the pistol failed to fire. Scott believed May to be reloading or clearing a malfunction during this time because he heard the sounds of metal surfaces rubbing against each other as if the slide of the pistol was being cleared or a magazine was being released and reloaded.

Farhan Ronny Ahmed (Student) - Shot multiple times while at the picnic tables outside the library.

Myself and Inv. Cherry interviewed Ahmed on Wednesday, November 26, 2014, at TMH. Ahmed was still in the Neurological Intensive Care Unit but felt strong enough to give us a statement. We conducted an audio taped interview.

He told us that he was studying inside Strozier Library and went outside with a friend (Blaine) who wanted to smoke a cigarette. Blaine's friend, Robert Cohen, joined them at the benches outside of the library. Blaine left to go to the bathroom while Ahmed stayed outside talking to Cohen.

While talking to Cohen he heard a "pop". He looked in the direction of where the sound came from (front of library) and he saw some smoke rising. He then saw a guy (May) walking around the side of the bushes toward them. He noted that May had a stern face and was carrying a silver colored gun with a black bottom (handle). May then pulled up the gun and shot at him three times. The first shot dropped him and is the one that severed his spine. One of the other shots hit his right upper arm and traveled into his torso coming to rest approximately 4 centimeters from his heart.

He told Cohen to call the police. Cohen called 911 using his phone then gave it to Ahmed and ran from the area. Ahmed talked to a dispatcher on 911 letting them know he had been shot and asked for help.

Police officers began arriving and one came to him. One of the officers was talking to him and at one point the officers ran toward the front of Strozier Library. Ahmed heard them yelling something similar to, "Drop your weapon! Drop your Weapon! Freeze!" He then heard 20-30 shots fired. An officer came back to him and stayed with him until paramedics arrived.

Robert Cohen (Student) - With Farhan Ahmed at the picnic tables - Clothing was hit with a bullet

On 11/20/2014, Inv. Huston and Inv. Wilder interviewed Robert Cohen. Cohen stated that he was standing at the table with his friend, "Ronny" (Farhan Ronny Ahmed), when he noticed a black male walking from the southeast corner of the library. The suspect (May) walked west along the South side of the building and shot at someone near the tables on the east side of the building. May walked closer to Cohen and Ronny. May shot at Ronny and he fell to the ground. Cohen said that May shot at him, and he felt the bullet pass him. May turned around and walked into the library. Cohen called 911 for Ronny. When Cohen saw May come back outside, he handed Ronny his phone and ran towards an FSU police car. Inv. Wilder and Inv. Huston checked Cohen's jacket and located an entry/exit hole on the back left side of his jacket consistent with a bullet. The jacket was collected as evidence. Cohen

drew a sketch of the scene and recorded May's path. The sketch was collected as evidence.

Chronological Summary of Shooting Victims:

Based on victim/witness statements it appears that May shot Jason Derfuss in the back, hitting his backpack, as he left the library. May then advanced toward Farhan Ronny Ahmed and Robert Cohen while they were at the picnic tables. May fired multiple rounds at least two of which struck Ahmed. It was later discovered that Cohen's coat had an apparent bullet hole in it. After shooting Ahmed, May walked back toward the library and shot at Elijay Velez multiple times. One of the rounds struck his bicycle and another penetrated through his clothing and grazed his torso. May continued toward the library and went inside. He walked behind the security desk and shot Nathan Scott in the upper leg then pointed the firearm at Paige McPhadden and attempted to shoot her but his firearm was empty or he had a malfunction with it.

OFFICER INTERVIEWS (Conducted Monday, November 24, 2014):

FSU Officer Oma "Zack" Nations:

On November 24, 2014, at approximately 9:23 a.m. myself and Inv. Scott Cherry conducted an interview of Florida State Police Officer Oma Nations. The interview was conducted at the Tallahassee Police Department in CID Interview Room #1 and was audio/video recorded. Officer Nations attorney Stephen Webster was present.

I informed Officer Nations of his Miranda Warnings verbally and in writing. He signed a written waiver of his rights and provided a statement.

Officer Nations advised he has been employed as an officer with the FSU Police Department since last June (2013). At the time of the incident he was a patrol officer assigned to the night shift and was working for Sgt. Wiley.

At the time of the initial radio call he was at the FSU Police Department with Officer Sloan ("O.J."). He initially became aware of the incident from a radio call of someone at Landis Green with a gun. That is the last radio transmission he remembered hearing leading up to the shooting (He acknowledged he knows there were more but that was the last one he remembered). He ran to his car and went to the scene as fast as he could.

He pulled up on the West side of the Green by the Dance building. When he opened his door a student ran up to him and told him, "he shot him, he shot him, you need to go over there". He began asking the student questions and began to try and get his rifle out of his vehicle. While trying to get his rifle out he heard a gunshot. He left his rifle, locked the vehicle and began running toward the gunfire. Prior to running he put the student behind a tree and told him not to move until someone came and got him.

Officer Nations did not know the Library had anything to do with the incident (The radio call he remembered was Landis Green) but went toward the library because a student had pointed in that direction. He worked his way toward the Library while scanning and looking around. He noticed that

students were running from the library and decided to go that direction.

Prior to approaching the area he had heard the radio call of a man with a gun, had been told by a student that someone was shot, and heard a gunshot from the area.

As he approached the library he observed a subject down on the ground by picnic tables in front of the library (Based on the location this would have been Farhan Ronny Ahmed). He tried to get to the subject to assess his condition while staying behind cover. After he got to the subject he noticed that it appeared he had been shot twice in the torso. He tried talking to the subject to try and get information but the subject was breathing heavily and struggling. While checking on the subject he looked to the front of the library and saw people running but one person standing still (Later learned to be Myron May).

He felt the person standing still must have been the person shooting. He left the victim and worked his way toward May. As he got closer he noticed May was facing away from him. May was doing something with his hands. As Officer Nations got closer May turned. When he turned Officer Nations clearly saw a silver gun. May was pacing back and forth and would go toward the library then back away.

Officer Nations felt that he should try and get as close to May as he could without May noticing him in case he had to shoot. By getting close it would keep people (students) from being in between them and also decrease the likelihood of shots missing.

Officer Nations went up the stairs and paralleled the library and when he noticed he was close enough to feel he wouldn't miss he started screaming at May, "Drop the gun! Drop the gun!" May looked at him by turning his upper torso and looking over his shoulder [Demonstrated by Officer Nations] while he was facing away toward the coffee shop in the library. May said something but he was talking quietly. Officer Nations continued screaming at him to drop the gun.

May said something to the effect of, "I'm gonna make you kill me" or "You'll just have to kill me". May moved his hands up and down then turned toward the library. When he turned toward the library the hand with the gun in it came up and May pointed it at him. Officer Nations heard a gunshot and started shooting. Officer Nations believed the shot was fired at him.

Officer Nations explained when he saw May raise the gun he felt that May's plan was to shoot him then go back in the library. When asked about whether or not there could be more potential victims in the library had May went back in he explained that in addition to being an FSU Police Officer he also went to school there. At any given time there could be 300-700 people in the library.

Once May was down one of the FSU Officers moved forward and handcuffed him. Officer Nations cleared May's gun by taking out the magazine and racking the one (round) in the chamber out. He then sat the gun back down.

Some people were saying there was possibly another shooter inside the library. He stayed outside while officers went in the library. A short time after (maybe 5 minutes) he saw another victim who had been shot in the leg (Nathan Scott) walk out of the library.

FSU Officer Daniel Cutchins:

At approximately 10:00 a.m. on Monday, November 24, 2014 myself and Inv. Cherry interviewed Florida State Police Officer Daniel Cutchins at TPD. The interview was conducted at the Tallahassee Police Department in CID Interview Room #1 and was audio/video recorded. Officer Cutchins' attorney Stephen Webster was present.

Inv. Cherry informed Officer Cutchins of his Miranda Warnings verbally and in writing. He signed a written waiver of his rights and provided a statement.

Officer Cutchins advised that he has been a patrol officer at Florida State University for just over two (2) years and worked for Sgt. Wiley at the time of the incident. Prior to coming to FSU Police Department he was an officer at Capitol Police for 3-4 years.

Officer Cutchins said that he first became aware of the call while he was at the FSU Police Station. He heard a dispatched call of a black male with a handgun. He ran to his car and drove to the area of Strozier Library. He saw a person a short distance away saying, "He has a gun" and pointing toward the library. He walked the pathway leading up to the library and saw an individual laying on the ground bleeding. While with that subject he heard Officer Nations telling someone to "Drop the gun!" or "Put the gun down!" He saw Officer Nations going toward an individual on the patio area in front of Strozier. He then drew his gun and ran toward the same individual.

When he got there he took a position at the base of the steps maybe on a step in front of the library. He saw a black male (May) "huddled up" with his hands by his face (demonstrated by Officer Cutchins) as if he was expecting something to happen. He had a gun in his right hand up in the air. He was facing away from Officer Cutchins toward Strozier Library.

May said something to the effect of, "Why don't you shoot me already" or "Why don't you kill me already". At that time he had the gun up in the air. Officer Cutchins advised that he screamed at May over and over again to drop his gun. At some point May pointed the gun at Officer Nations and fired off at least one round in Officer Nations direction. Officer Cutchins believed that May was trying to shoot and kill Officer Nations. Officer Cutchins advised he returned fire until May was on the ground and the gun was no longer in his hand.

After the shooting stopped Officer Cutchins took the used magazine out of his gun and loaded a fresh magazine. He then went back to the victim he had encountered (Farhan Ronny Ahmed). Ahmed was in bad shape. He told Officer Cutchins, "I'm not going to make it". Officer Cutchins tried to comfort him and keep him conscious by talking to him. He stayed with Ahmed until Emergency Medical Services (EMS) arrived.

Stephanie Webster was present.

Inv. Cherry informed Officer Staats of his Miranda Warnings verbally and in writing. He signed a written waiver of his rights and provided a statement.

Officer Staats worked for FDLE Capitol Police for approximately 2.5-3 years. He came to work for TPD in 2012 and has been assigned to patrol since coming to work at TPD.

He advised that he first became aware there was an incident at Strozier Library while he was in the area of Copeland and Tennessee Streets (Mike's Beer Barn). He had his in-car radio set to scan and heard the call go out on the FSU Police channel. He heard radio traffic that they had a victim down and a potential active shooter and he responded.

When he arrived in the area he saw approximately 20 students huddled on the East side of the library. He approached them and asked about the location of the shooter. No one knew but someone pointed toward the front of the library. Officer Staats then drew his handgun and ran toward the front of the library. As he turned the corner of the library he saw an individual (May) standing there and an FSU officer on the other side of him. FSU Officers were yelling for the subject to "Drop the gun!" Officer Staats saw the suspect holding a gun in his right hand.

Officer Staats realized that he was in a cross fire situation and moved around to the FSU Officers at the base of the stairs in front of the library. Officer Staats moved up between FSU Officers and pointed his firearm toward May. May was facing sideways, or slightly quartering away, to Officer Staats position. Officer Staats yelled at least two times, "Drop the gun!" He noticed that May shook his head back and forth/side to side (indicating "no"). At that time May had the gun down to his right side. May then raised the gun toward where FSU Officers were and fired a round. Officer Staats heard the gun go off and saw the muzzle flash from May's firearm. Officer Staats advised that he was afraid May was going to shoot an officer or student. After May shot, Officer Staats returned fire. After the shooting an FSU Officer moved forward and handcuffed May.

As other officers arrived he was assigned a buddy officer (Ofc. Ouzts). Lt. Johnson directed him to go to TPD.

FSU Officer Parise Adams

At approximately 2:00 p.m. on Monday November 24, 2014, myself and Inv. Cherry interviewed Florida State Police Officer Parise Adams at TPD. The interview was conducted at the Tallahassee Police Department in CID Interview Room #1 and was audio/video recorded. Officer Adams' attorney Stephanie Webster was present.

Inv. Cherry informed Officer Adams of his Miranda Warnings verbally and in writing. He signed a written waiver of his rights and provided a statement.

On the night of the shooting he first became aware of the call while at the FSU Police Department. After hearing the radio call of a black male with a gun at the library he drove to the library. While enroute dispatch advised shots had been fired. After arriving he heard that a person was down. As he approached the library he saw Officer Cutchins with a subject on the ground. The subject was bleeding. (Based on the description this was Farhan Ronny Ahmed). While trying to get information from Ahmed about the shooter he heard Officer Nations screaming for someone to put the gun down.

He could see Officer Nations addressing the suspect. He pulled his gun and ran to where he was. When he got there Officer Nations was to his left. Officer Adams screamed at May multiple times to "Put the gun down!" but May did not comply.

Officer Adams noted that at one point May had his firearm pointed up and was holding it against his forehead. Officer Adams screamed at him that, "It doesn't have to end like this. Just put the gun down." At that point May brought the gun down and swung around. Officer Adams stated that he had already walked up on people who had been shot and believed "it was a matter if he was going to be the next one hurt". When May turned the gun toward him he felt he had no choice and started firing. When Officer Adams was asked what he believed would have happened had he not acted, he responded by saying he believed May would have killed him.

After the shooting stopped he went up to May. He saw Officer Sloan kick the gun out of May's hand. Officer Sloan and Officer Adams then handcuffed May. He remembered hearing Sgt. Wiley tell Officer Nations to clear May's gun. When he looked back again he saw that the magazine had been removed from May's gun.

Officer Adams searched May's pockets. As he pulled out his right front pocket, bullets and papers fell out. When he pulled out his left front pocket, a phone, keys, more bullets, a wallet and a letter (piece of paper) were in it. The piece of paper had blood on it. Officer Adams was not wearing gloves but Officer Amison (TPD) was present by this time and was wearing gloves. She took the paper out and they noticed it had "Next of Kin" on it with phone numbers and names.

Officer Adams radioed for EMS for May and the victims. He also provided dispatch with May's name from his driver's license that was in his wallet. He then set all the items on the ledge of the planter where the incident had taken place.

He stayed with May until he was relieved and assigned a "buddy officer". He then came to TPD.

FSU Sgt. Cliff Wiley

At approximately 3:00 p.m. on Monday November 24, 2014, myself and Inv. Cherry interviewed Florida State Police Sgt. Cliff Wiley at TPD. The interview was conducted at the Tallahassee Police Department in CID Interview Room #1 and was audio/video recorded. Sgt. Wiley's attorney Tom Schulte was present.

I informed Sgt. Wiley of his Miranda Warnings verbally and in writing. He signed a written waiver of his rights and provided a statement.

Sgt. Wiley advised that he has been employed at the Florida State Police Department for 15 years and at the time of the incident was assigned as a patrol sergeant. The FSU Officers involved in this shooting were all on his squad.

Sgt. Wiley advised that he first became aware of the incident while he was in his office (FSU Police Department). A radio call came out that there was a subject with a gun at Strozier. He remembered a radio call that had come out at some point saying the suspect was running toward Thagard. While enroute Officer Sloan (who had gotten information from the maintenance person) radioed that the suspect had been seen running back toward the library.

When he pulled up he saw the victim outside the library (Farhan Ronny Ahmed) with Officer Cutchins. While there he heard Officer Nations hollering, "Put the gun down! Put the gun down!" He ran to the area and took a position by a large planter. May was standing at the top of the steps in front of the planter and Sgt. Wiley was at the bottom of the steps by the planter.

He could see May had something in his hands but could not tell for sure what it was as he was facing May's back and May was quartering away from him. Officer Nations was continually yelling for him to "Put the gun down!" Sgt. Wiley then saw May turn the gun toward Officer Nations and fire in his direction. Sgt. Wiley then shot at May two times.

When asked about what his fears or concerns were when he saw May turn the gun toward Officer Nations and fire, Sgt. Wiley said he thought May had just shot his guy (Officer Nations) so he shot. After the shooting he looked and saw that Officer Nations was still standing. Sgt. Wiley stated that if he hadn't shot he felt that May would have continued to shoot and kill his guy (Officer Nations).

After the shooting he assigned Officer Nations to stay with May's gun. He had Officer Adams stay with May and sent Officer Cutchins back to the victim (Farhan Ronny Ahmed).

Sgt. Wiley and Officer Sloan went in to the library and got victim Nathan Scott. Sgt. Davis (TPD) took command of the scene and Sgt. Wiley came to TPD.

PHYSICAL EVIDENCE (Other than on scene at FSU)

Myron May's Cellphone

At the time of the shooting May was in possession of a white Samsung Galaxy S5 cellphone. On 11/20/2014, Inv. Federico obtained a search warrant for the phone. The phone was examined by Inv. Dilmore (Technical Support Unit) and a cellbrite report was made. Inv. Cherry examined the report which provided information that May felt he was a "targeted individual". (See Inv. Cherry's Supplemental Report for details).

Of note, text messages on the phone start in October 2014. May and Rose Campbell exchanged numerous text messages where May became defensive about not having schizophrenia.

On November 19th, 2014 leading up to the shooting he exchanged numerous text messages and phone calls with Renee Pittman. An Internet search of Pittman showed she has written multiple books

to include: Remote Brain Targeting; Diary of an Angry Targeted Individual; and You are Not my Big Brother. (Inv. Cherry spoke to Pittman by Phone - see supplemental report).

Below are some excerpts from the text conversation between Pittman and May on 11/19/2014 leading up to the shooting. A review of May's call log also showed that he called Pittman multiple times and received a call from Pittman.

6:37 p.m. An outgoing call from May to Pittman that lasted 13:59 seconds.

At 7:11 p.m. May sent Pittman the following message:

Renee: I sent ten packages priority mail, certified mail, return receipt requested today, November 19, 2014. Nine of the return receipts are going to you because I anticipate that I'll be gone at that point. The other return receipt, which is the package being mailed to you, is going to Derrick Robinson from FFCHS. Right now, I'm being direct hit as I type this. I hope you get it.

7:18 p.m. and 7:21 p.m. short outgoing calls from May's phone to Pittman.

7:21 p.m. an incoming call from Pittman that lasted 45:41 seconds.

At 9:13 p.m. Pittman sent the following message to May:

It appears you are being used to play on my humanity side with the suicide crap. You never (text ended).

At 9:15 p.m. May responded:

No, Renee. Stop being paranoid. I'm a genuine guy. And please save that e-mail offline so it won't get deleted. I'm still getting hit right now

At 9:18 p.m. Pittman sent the following:

You never mailed anything and you know it. I guess the HNIC thought they had a handle on me through my sympathy. You are a shill! You say you want to kill yourself. Go for it. That is your business and not mine. Sorry kid we must now part ways. I can't save you.

9:18 p.m. short outgoing call from May to Pittman.

At 9:20 p.m. May sent:

Calm down now!!! My death can't be in vain. I devised a scheme and you are about to mess it up real bad Renee

9:21 p.m. and 9:41 p.m. short outgoing calls from May to Pittman.

It appears that May's phone was powered down after the shooting. When it was powered back up the following message from Pittman came through:

"If you kill yourself you hurt our effort and allow this program to continue. You can bet the media will portray you as schizophrenic and even use your pediatric ex girlfriend and others to prove it saying you were hearing voices. Don't involve me."

Myron May's Laptop

May's laptop was recovered at the Campbell residence in Tallahassee (See Inv. Huston's Supplemental Report for Details). At the time of the recovery, a video May had made was playing on a loop. A later search of his computer revealed he had made three (3) videos.

In addition to the videos on May's laptop computer, there was what appeared to be a documented script for the videos.

Based on an examination of the videos Inv. Dilmore (Technical Support Unit) believes the videos were made on 11/18/2014. In the videos, May appears to be wearing the same shirt and sweater vest he was wearing at the time of the shooting on 11/20.

Video #1

The video is approximately 41 minutes in length. During the video, it appears as May is following an outline as he talks.

May began by saying it is with a heavy heart that he is making the video and refers to it as his "last words." He goes on to describe how he is a victim of covert harassment, electronic harassment and gang stalking. He said that he is what is called a "targeted individual."

In the video, he described the goal of "gang stalking" as being to drive a targeted individual crazy. He said that it was a comprehensive program and a government program which involves having people follow the targeted individual. He described how people followed him, even into church. He went on to give a detailed description of what he felt gang stalking was and that the tactics have been employed against him to make him appear to be a crazy person.

He described gang stalking to include "Control Panel Stalkers" who are people in an operations center that monitor all the targeted individuals throughout America. May described most of the people who have harassed him are wearing dark sunglasses and look at him in weird ways to try and make him paranoid or arouse fear in him.

May also described that when he was in his apartment he would hear voices explaining what it was he was doing. For example, if he went to the kitchen the voices would say, "He's headed to the kitchen" or if headed to the bathroom the voices would say, "he's headed to the bathroom." He also talked about "brighting" where people shine bright lights into the home or at you while in a vehicle. It is a way of harassment not allowing your mind to be at ease.

He said stalking also involves a "noise campaign" which happens at all times of the day. The goal is to keep individuals from getting sleep which exacerbate the feelings of paranoia and fear. It includes loud cars and loud neighbors. May described how he was the victim of a noise campaign while in Houston, TX. It was at that time he realized he was a "targeted individual." While talking about this he again refers to making the video as his "last words."

He talks about where people break into an individual's house and rearrange their personal belongings and yard ornaments so when the targeted individual returns home he sees things are out of place. This

arouses fear and paranoia.

He also discussed a technique called "mobbing" where the targeted individual is harassed by several stalkers at one time. It is designed as a scare tactic to drive the individual into paranoia. May said it happened to him on several occasions. He gave an example of 5-10 cars would pass him all at one time. All the occupants had on dark shades (glasses) and instead of watching the road they were watching him.

He discussed a technique called "hacking." It includes where remote access is gained to the targeted individuals electronic devices. It is designed to cause fear, apprehension and paranoia. He discussed one of his experiences that included trying to purchase one of Renee Pittman's books, who is a targeted individual. The browser on his phone would close.

May described a book that covered some of the topics a targeted individual deals with. May said the most critical aspect of gang stalking was hard to believe but it was real. He said it is the lynch pin that holds their program together and helps them keep it a secret from everyone else in society. It is called electronic harassment and includes the use of directed energy weapons. During the video, he gives examples of his experiences as being targeted with the directed energy weapons.

Psychotronic Weapons known as voice of God technology and image induction technology are also used against a targeted individual. Through the use of microwave radio frequency radiation control, panel stalkers can induce sound in the targeted individual's ear.

Image Induction Technology is used to induce images into a targeted individual's mind. It is usually done while the individual is sleeping. Control panel stalkers can also see images from the targeted individuals mind.

Video #2 (Approximately 33:30 long) - This is the Video that was playing on a loop when the computer was found.

May opens the video by saying it is with a heavy heart that he needs to make the video. He begins the video with a prayer. During the prayer, he thanks the Lord for the 31 years he has spent on earth. He asked for forgiveness for his past, present, and future sins. He also asked to help targeted individuals. He asked for forgiveness for his actions and to please let those who are harmed in any way by his actions to give them a spirit of contentment and peace and he is sorry. The rest of the video consisted of "some good byes" to numerous family members and friends.

Video #3 (Approximately 33:20 long)

"Part 3 of his personal story as a targeted individual"

He said he wants to give an explanation of why he is making the video and some of his actions that will transpire after the video. He said it was a difficult decision for him and he spent the better part of a week thinking about it and went on to talk about the torment of targeting.

He said life was not supposed to be people sitting in a control room manipulating how you live day to day and moment by moment. He felt he was in a straight jacket in a standing room only space. Targeted individuals get grief, pain, hardship and loneliness and it is not fair.

May said the purpose of the video was that maybe some other targeted individuals would have a shot at living a normal life that he did not get to live. He said he hoped his story would get some media attention and targeted individuals would capitalize on it to have a normal life.

The biggest reason he is doing it is he is already a targeted individual who has been subjected to torture. If the program can stop, then maybe other people won't be subjected to it. He discussed wanting elected officials and media to look into targeting. He also addressed a number of people he felt participated in his stalking. They included individual's from his life and also Dr. Robert Duncan who he blamed for causing a lot of pain and hardship to a lot of people. Targeted individuals are tortured every day because of what he helped create.

He also spoke in length to other targeted individuals. He said he was sending a packet to several of his friends with the video and letters and other documentation with his experiences as a targeted individual. He encouraged them to post and re-post the video as much as they can on social media so his story does not die.

May said to the families of anyone impacted as a result of anything in relation to the video... "They probably don't want to hear or care about what he has to say." He asked them to forgive him. He said he knows they will think he is crazy or mentally ill but he is not, he is perfectly sane. This was the best method he could come up with to fight.

May brought up two other individuals that he said were "active shooters and targeted individuals." The names he brought up were Jiverly Wong and Aaron Alexis. He said to the families that were harmed by other targeted individuals they have a special reason to not let his story die and to keep fighting to get rid of the program because they lost loves ones as a result of the program.

May addressed his situation was not a mental health issue but was the result of targeting.

Toward the end of the video, he gives a message (not in form of a prayer) to God and asked for forgiveness for what he was about to do. He then prayed to God and ended the video.

Documents From the Campbell Residence

Myron May left a five (5) page document entitled "My Experiences as a Targeted Individual" at the Campbell residence.

The first paragraph of the document is as follows:

My deepest regret is that I did not make a more diligent effort of documenting my experiences as a targeted individual along the way; however, this document is my feeble attempt at recounting my experiences thus far. First off, to anyone that may read this document, take a brief moment to pray for my soul. What I am about to do I have deep regret for; however, I feel that my options are extremely limited. Because I am a targeted individual, everything has been taken away from me. I have literally been robbed of life through psychological, financial, and emotional hardship.

May went on to describe how he had been "Targeted." The first experience he documented was September 7th, 2014 while working for the Third Judicial District Attorney's Officer in Dona County, New Mexico. He wrote that his apartment had been broken into, his phone tampered with and he was

followed by various individuals in unmarked cars. Through electronic harassment, individuals convinced him he was guilty of a crime. He tried to turn himself in at a local jail, but they would not take him.

Because he was an overachiever he would work late at the District Attorney's Office. He was harassed by people constantly peeking around corners at him. Because of the harassment he resigned from the District Attorney's Office and traveled to Houston to get his old job back.

He went on to describe an encounter with his old boss. He described the situation as being part of an elaborate scheme to put him in financial hardship, thereby making him more amenable to harassment and less able to fight the issue. Upset and jobless, he returned to Las Cruces to continued harassment and being followed.

After returning to Las Cruces, he was subjected to a constant noise campaign designed to induce sleep deprivation. May felt that through electronic harassment his life was constantly threatened. Fearing for his life, he decided to move back home to Wewahitchka, FL.

May described additional instances he felt were electronic harassment. He also described encounters with law enforcement where he felt harassed and stalked.

While traveling to Florida, he stayed with a friend in Houston. The family there participated in his harassment by talking loudly and blaring a television. After he left Houston the electronic and other harassment continued.

After arriving in Florida the harassment (mainly electronic) continued which was very debilitating and impactful. He felt individuals were recruited to harass him and he had been stalked.

May documented license plate numbers of vehicles he felt had been following him. He also gave a list of "Other Targeted Individuals" that included Aaron Alexis (Washington Navy Yard Shooter) and Jiverly Wong (Binghamton Shooting - Killed 13 people in NY).

In addition to the above documents, the papers also included a page titled "TO DO LIST FOR OTHER WHILE I'M GONE." The list describes things that needed to be done with May's personal belongings:

- Included in the documents was a letter to Ms. Mitchell and other addresses dated 11/17/2014. May wrote:

...Enclosed within this letter, you will find a USB flash drive containing a personal testimony from me about the financial, emotional, and psychological pain that I have endured over the course of the past few months since I discovered I was a "targeted individual."

In the letter he also wrote: I have not told a single person exactly what I intend to do - and only you eight people know that I intend to do anything at all - but my goal is to garner some much needed media attention to the plight of targeted individuals because we are a marginalized group with few financial assets...

In the letter May asks the people he sends the letter to not to allow his story to die and includes a form letter to Representatives/Senators about "Targeted Individuals." From copies of certified mail receipts it

appears that May sent ten (10) of the packages to various people to include Renee Pittman.

- On 12/17/2014, I spoke to U.S. Postal Inspector J. Tabb regarding the packages May had mailed. He advised he believed all the packages had been seized and were in the possession of the USPS. The packages contained writings on May's experiences as a "targeted individual" and a flash drive believed to contain the videos he made at the Campbell residence (3 videos).

Myron May's Vehicle (2010 black Chevrolet Equinox)

The vehicle was located at McDonald's at 672 W. Tennessee Street based on the text May sent to Aymbriana Campbell. It was towed to Lake Jackson Towing to be held as evidence. On 11/20/2014, Inv. Federico obtained a search warrant for the vehicle.

On 11/20/2014, around 11:00 a.m. myself, Inv. Federico, and Inv. Cherry searched the vehicle at Lake Jackson Towing. The following items were found inside the vehicle:

- On the front passenger floorboard was a gun receipt from Bay Gun's and Gear located at 3115 Highway 77, Panama City, Florida 32405. The receipt was dated 11/13/2014, and was for a Ruger Model SR22 Pistol and 2 boxes of Aguila .22 ammunition. May came to Tallahassee prior to the end of the three day waiting period and had not picked up the firearm.
- Also on the front passenger floor board were 2 boxes of Aguila .22 caliber ammunition.
- In the glove box was a badge for the 3rd District Attorney's Office in Las Cruces, NM.
- In the rear cargo area of the vehicle was a .12 gauge Winchester Pump Shotgun with serial number L1543223.
- Also in the rear cargo area was a black BB Gun modeled after a "Beretta".

ADDITIONAL INFORMATION:

- For a detailed description of the crime scene and items impounded see Forensic Specialist Kornegay's report.
- Forensic Specialist Kornegay impounded the piece of paper that Officer Adams removed from May's pocket. The piece of paper had "Next of Kin" information listing May's mother and Rose Campbell.
- After having reviewed the library video, I saw May was carrying a pink bag and a book when he was in the library. I asked Specialist Kornegay if he had seen those items when he processed the scene. He told me he had seen a pink bag in the planter next to where May's body was. At the time he did not know it was evidence and did not impound it. However, he did search it and noted it had nothing in it.

Specialist Kornegay also remembered seeing a Bible in the lobby area by the coffee shop. He did not know it was evidence and it was not collected. The book appears in a photograph taken by Specialist Kornegay. It appears to be the same size as the book May was carrying but it is unknown if it is actually what May was carrying.

After learning the above from Specialist Kornegay, I contacted FSU Sgt. Wooten and he had an officer

go to the Library and check lost and found. There was a bible but when I described it to Specialist Kornegay he said it was not the one he saw. Additionally, it does not match what May was carrying in the video. The officer also looked for the pink bag in the planter but could not locate it.

On 12/17/2014, I learned from FSU Crime Scene Investigator Wisecup that he had impounded a Bible from the area where Specialist Kornegay had photographed one. It is unknown at this time if it is May's Bible.

- ATF Agent Magruder was asked to assist with the investigation by tracing the firearm May used in the shooting (Lorcin .380). From the ATF Investigation, it appears the gun was stolen during a residential burglary in Panama City Beach in 2005. It is unknown how May came to be in possession of the firearm.

- Based on a review of May's text messages, it appears he got to Tallahassee on 11/15/2014. On that date, he texted Rose Campbell he was coming to see her.

- During the investigation, a number of individuals came forward believing they saw May at FSU Campus prior to the shooting. On 11/20/2014, Dorothea Ballai (FSU Student) came to the TPD duty office to report she had possible information regarding the suspect from the Strozier Library shooting. She said that on Sunday, 11/16/14, she was attending a review session for her MAC1114 class at Fischer Hall, room 275. At some point during the class, the teacher called out to a male sitting in the back of the class. The teacher asked the male if he was a student. The male appeared flustered and indicated he was a "past student" and was just "sitting in." A short time later, Ballai got up to go to the restroom. She indicated the male was staring at her and appeared to be acting strangely. She described him as a black male with a bald head who was nicely dressed. He appeared out of place in the class of college age individuals. After the FSU Shooting, she saw a picture of Myron May and recognized him as the person who had been in the class.

I checked with FSU Sgt. Wooten who advised there were no video cameras in the described area.

- On 11/20/2014, I received a phone call from another student (Maya Taylor) who thought that she was approached by May in the 500 block of W. Call Street on October 23, 2014. She said that the subject approached her and her roommates and asked them if they were students at FSU. He advised them that he was an alumni of FSU and a lawyer. He was wearing a dark colored zip-up sweater type shirt and was carrying a "man purse" which could have also been a computer bag but it was unknown by the witnesses at the time. They stated he was very polite, but "pushy" in regards to taking his twitter number and responding to him by twitter. He was seeking encouragement from students for "Beyonce and J Z" who he stated were coming to perform for FSU homecoming. The witnesses felt this was very strange and pretended to take his twitter account information but did not in fact do so.

Witness Myah Taylor said, that after watching things in the media, she was 100% positive May was the same as the subject who approached them. Inv. Daws met with the witnesses and obtained a statement. He also checked the described area for video cameras but located none.

- It should be noted, based on evidence from May's cell phone it appears he was not in Florida on October 23.

- Inv. Kerce and myself made multiple attempts to obtain video from McDonald's at 672 W. Tennessee Street (Where May left his car). As of this report, a request has been made to Ruben Martinez (McDonald's) but the video has not been received. It should be noted Martinez has told me in unrelated

5. I have several personal belongings at my ex-girlfriend's, Danielle Nixon, house in Las Cruces, NM at [REDACTED]. Her phone number is [REDACTED]. Orchestrate that with her.
6. I have several items in storage in Houston, Texas at Public Storage located at 5460 Addicks Satsuma Road, Houston, TX 77084. There is a payment due for these items on December 1, 2014, in the amount of \$83.00. Please either make the payment or arrange to have these items picked up from storage. My friend, Kimberly Snagg, lives in Houston, TX. She may be able to help with picking these items up. Her phone number is [REDACTED].
7. I am pretty sure that Ebony Casarez will want Little Bit. We got this dog when we lived together. Her and her daughter, Aaliya Williams, love Little Bit as much as I do, and I am sure that they will want to get her and take care of her. Ebony's phone number is [REDACTED].
8. Gather my personal belongings from the guest house at the Taunton Family Children's Home

MY EXPERIENCES AS A TARGETED INDIVIDUAL

My deepest regret is that I did not make a more diligent effort of documenting my experiences as a targeted individual along the way; however, this document is my feeble attempt at recounting my experiences thus far. First off, to anyone that may read this document, take a brief moment to pray for my soul. What I am about to do I have deep regret for; however, I feel that my options are extremely limited. Because I am a targeted individual, everything has been taken away from me. I have literally been robbed of life through psychological, financial, and emotional hardship.

I first realized that I was a target while I was working as an Assistant District Attorney for the Third Judicial District Attorney's Office in Dona County, New Mexico. I tried going to the police about my situation. On or about September 7, 2014, I went to the Las Cruces Police Department to make a report of my experiences. The interior of the LCPD office was locked, but there was a phone in the vestibule, which dispatch answered. I informed dispatch that I wanted to make a police report, and they sent an officer out to my location. I believe the officer's name was Kenneth Davis (Caucasian male that appeared to be in his 20s). The officer took notes of my experience; however, no police report was ever made. Nevertheless, there should be a record of my phone call with Dispatch. That morning, I got invited to the gun range by my girlfriend's friend's husband, Robert Kitcey (rkitcey@gmail.com). When I met up with him later that morning at Starbucks, I informed him and another guy that was with him of the police report that I had just made. If you need to get in contact with Robert, you can contact my ex-girlfriend, Danielle Nixon [REDACTED]. I don't remember the other guy's name; but he is an engineer from Michigan (Caucasian male in his late 40s or early 50s), and his wife's name is Betty (Kenyan woman who appears to be in her early 40s, with a bald haircut).

My apartment was broken into, and my phone was tampered with. I started being followed by various individuals in unmarked cars. And on one occasion, I was followed by an individual in an LCPD sport utility vehicle cruiser. Through electronic harassment, these individuals convinced me that I was guilty of a crime. As a result, I attempted to turn myself in at the Dona Ana County Detention Center on three separate occasions. I was literally escorted to the jail by about ten cars; however, no one went inside the jail with me. Each time I attempted to turn myself in, the cars waited in the parking lot (watching me go inside the jail). But the jail informed me that they had no paperwork for me. Then, each time I left the jail after being turned away, the cars that escorted me into the jail were gone.

I continued to be followed. I informed my girlfriend, Danielle Nixon, who resides in Las Cruces [REDACTED] and my friend, Kirton, who also resides in Las Cruces [REDACTED] of these instances. Because I was an over-achiever in my position, I frequently worked late. When I was in the office alone after hours, I would consistently see individuals peeking around corners at me. As a result of this harassment, I eventually resigned from my Assistant District Attorney position and traveled to Houston, Texas to get my old job back. I met with my old boss, Alfonso Kennard, on the evening of Friday, October 10, 2014, to discuss rejoining his law firm, Kennard Law, P.C. as an Associate. On that evening, Kennard offered me my old job back at a base salary of \$50,000 per year plus 20% commissions on all settlements or judgment obtained on my cases.

After we had reached terms on that agreement, Kennard called his driver, Randy [stout, Caucasian male who appeared to be in his late 40s], to take us to another place because we had been drinking and should not have been driving. Before Randy arrived, Randy's friend Edwin arrived. It was unclear to me how Edwin could have possibly known who we were, but he approached Kennard and I at the bar and claimed that he was there to meet with Randy. When Randy arrived, we had one last drink. As we were leaving, I went to my car to retrieve my ID and wallet. I returned to find Randy and Edwin whispering to Kennard. When I returned, everyone acted very unusual toward me; it was not the same jovial conversation that had preceded this occurrence. Then, we loaded up into Randy's SUV to go to the next location. As we were driving to the next location, Kennard leaned over and asked me, "if I wanted to take a bump"—suggesting that if I wanted to take a bump of cocaine Randy or Edwin could get it for me. I vehemently assured Kennard that I did not want to take a bump. Nor had I ever taken a bump.

On Saturday, Kennard would not respond to my phone calls or text messages, which was strange because for the two days prior to that he had been very responsive. Kennard's distance did not arise until after his private discussion with Randy and Edwin. As a result of this strange behavior, I informed Kennard via text message that I may have to depose him in a lawsuit. Thereafter, Kennard called me to arrange another meeting. According to Kennard, he wanted me to discuss my re-joining the firm with his partner, Terrance Robinson. We arranged a meeting for that Monday, October 14, 2014. On Monday, we met at the A-loft, which is located at 5415 Westheimer Road next to Kennard's law office. While there, we had drinks. Kennard and Robinson had two drinks, and I had one drink. Then, we went across the street to The West End Bar &

Grille, which is located at 5320 Westheimer Road to have a meal. Shortly after we arrived, Randy showed up and suggested that we go to another restaurant down the street. Because Kennard agreed to pick up the dinner tab, I agreed to go. At the restaurant, Kennard kept insisting that I join him outside to discuss matters with him. He again brought up the conversation about me taking a bump of cocaine, and I again insisted to him that I have never taken cocaine.

After dinner, Randy dropped me off at my car, which was parked near The West End. The following day, I attempted to call Kennard, but my phone number was blocked. I attempted to call Kennard a couple of times after that, but my phone number was still blocked. While I do not have last names for Randy, the driver, or Edwin, I am certain that whatever was said in that whisper cost me my job. This situation was all a part of an elaborate scheme to put me in financial jeopardy, thereby making me more amenable to harassment and less able to fight the issue. Upset and jobless, I returned to Las Cruces to continued harassment and being followed.

On the morning when I was leaving Houston, my tire was punctured and flattened while in the driveway at [REDACTED] (residence of Monica Johnson), where I was staying. When I returned to Las Cruces, I had to take my tire to On Sale Tires to have it repaired. There should be a record of that repair with On Sale Tires. Further, after returning to Las Cruces, I was subjected to a constant noise campaign designed to induce sleep deprivation in me. My neighbors played loud music, screamed, and people frequently made noise right outside my windows. Not only did this happen at night time, but this happened during the day as well. Maintenance staff, which almost never worked outside my window previously, worked and made noise right outside my window everyday.

In addition through electronic harassment, my life was constantly threatened. Fearing for my life, I decided to pack my things and move back home to Wewahitchka, FL. As I was loading my Uhaul to pack my things on October 21, 2014, my life continued to be threatened through electronic harassment. Additionally, as I was loading my Uhaul, there was a middle-aged man parked in the arroyo across the fence from my apartment complex (Quail Ridge Apartments - 251 North Roadrunner Parkway). He was driving a gray Dodge Durango 4 x 4 with a camper shell that had a Colorado License Plate, 285 YPI. This man got out of the driver-side of his truck, removed a blanket from the camper shell, and unsheathed a firearm from the blanket. Then, the most frightening thing happened. The man pointed this firearm at me, as I stood inside the trailer portion of the Uhaul truck. I jumped off the truck, ran towards my apartment, and called 911. There should be a record of this call with dispatch.

While officers were en route to my location, the man wrapped the firearm back in the blanket and put it in the right side of the camper shell. Five officers responded to the scene of Quail Ridge. These officers were acting very aggressively towards me as though I was the assailant and not the complainant-victim. Unfortunately, I was only able to get four of the officers' names: Officer Shadd; Officer Frank Gomez; Lieutenant W.C. Jackson; and Officer Guerra (who aggressively refused to give me his first name but whose badge number was L650). Officers claimed that they searched the mysterious man, but I watched this alleged search with my own eyes. They never searched his person. Nor did they even go to the right side of the vehicle, where I saw this man place the gun. They merely peeked inside the driver-side of the pickup truck, which should hardly be characterized as a search.

After talking with the man a little while longer, they came over to me and claimed that the man did not have a gun and that they had conducted a thorough search of his person and the vehicle. The continued to speak to me very aggressively and insisted that this man had driven from Colorado to Las Cruces, New Mexico to survey the land that he was on. The land that he was on is located directly behind Golden Mesa Las Cruces Independent Senior Living Community. If a survey of that property was requested, there should be documentation somewhere. I am certain that if you search, you won't find any such documentation. It does not even make sense that someone would travel all the way from Colorado to conduct such a survey, especially in light of the fact that you have to be licensed in New Mexico to conduct surveys. While it's certainly possible that this man could have been licensed in New Mexico, it is unlikely that Golden Mesa or the surface owners of the property behind Golden Mesa would not have simply hired a New Mexico-licensed surveyor. This experience, particularly the aggressive behavior of the officers, convinced me that law enforcement was very much involved in my harassment.

I am not sure what information was given to the leasing office at my apartment complex, but shortly after this incident, I received a letter on my door informing me that it was a notice to vacate my apartment. There should be a record of this notice and/or any interactions with law enforcement in the Quail Ridge leasing office. The harassment did not stop on this day with that incident. My life continued to be threatened via electronic harassment. I was literally threatened to leave Las Cruces immediately. As a result, I left several of my belongings in my apartment at Quail Ridge, which was

Apartment 1407. The leasing office should likewise have information regarding me leaving my belongings on both the interior and exterior of my apartment. One of the things that I left in my apartment was my old cell phone (a red Samsung Galaxy S3). I had gathered several license plate numbers in this phone, but because I was told through the electronic harassment that I would be left alone if I left Las Cruces and left my phone in the apartment, I did. I, however, had forwarded some of this license plate information to Altrus Campbell via text message and email. In addition, I gathered some license plate information in the iPhone that was issued to me by the Third Judicial District Attorney's Office. I sent a Preservation of Evidence email to John Willis, IT personnel with the Third Judicial District Attorney's Office, on October 21, 2014, in reference to preserving the information in that cell phone.

While traveling from Las Cruces, NM to Wewahitchka, FL, I was repeatedly tailgated and cut off by both patrol cars as well as regular cars. I was almost run off the road at one point in Kerr County, TX. Further, while I was in Kerr County, Texas, I was pulled over and officers searched my vehicle for no reason whatsoever. I did not give officers any consent to search my vehicle. Nor did they show me a warrant. They made me get out of the vehicle. They handcuffed me, and I stood in the heat with no shoes on for approximately three hours. Several officers were present, including Chief Deputy Clay Barton and Deputy Eli Garcia. There were about six more officers, but unfortunately due to the aggressiveness and hostility that the officers showed me, I was not able to get the others' information. Nevertheless, there should be Kerr County dispatch reports of the other officers that were involved. The officers held me there while a K-9 unit arrived from another county. My belongings were packed in plastic bins, and they literally opened every single plastic bin and searched it on the false claim that the K-9 had alerted to something inside the truck. The dog seemed more interested in the toy that the dog's handler was holding than anything in my Uhaul, and of course, they never found any narcotics.

I took a rest break in Houston, Texas on my way to Florida. I stopped at the residence of Monica Johnson again. While there, the noise campaign continued. In fact, they recruited the Johnson family to participate in my harassment. Marciel (pronounced Marshall) is typically a quiet and reserved person, but he was continuously speaking very loudly and screaming throughout the evening. I was sleeping on the couch in the living room. While he was in his bedroom downstairs, he had his bedroom television blaring. I believe that they were recruited to participate in my harassment based on a threat of Marshall going to jail for possession of marijuana. At about 3:00 am that morning, while I was sleeping, Monica came out of the room screaming about her daughter, Britney's car being repossessed. While it's certainly plausible that Britney's car, a red SUV, could have been repossessed, Monica went on and on about the repossession—slamming doors, dropping things, and yelling at the top of her lungs. Eventually, realizing that I was not going to get any sleep in that house, I got up and continued my journey to Florida.

Of course, the electronic and other harassment continued for the duration of my trip. I was continuously cut off and tailgated in traffic the entire way. I eventually made it to Florida. When I got to Wewahitchka, Florida (and since I have been in Florida), the harassment has continued, mainly through electronic (Voice of God – see *Dr. Robert Duncan*) harassment. This harassment has been very debilitating and impactful. They have recruited other individuals to participate in harassing me, including Buddy Parker (older, Caucasian male that is married to Ann Parker), Clifford Jones (son of Louise Jones), Roy Myers (who is my cousin and the brother of Michael Myers and Melody Williams), and Demetrious (not sure what his last name is, but he is the brother of Warren Bowers). There have been others that have been sent out to stalk me as well. Unfortunately, I don't know these other individuals' names. On one occasion, about two weeks ago, I was in Rich's IGA standing in front of a three-foot, front-facing section of Little Debbie snack cakes. Two gentlemen came into the store and walked directly over to me. One of the gentlemen stood inordinately close to me, very much in my personal space. When I turned to my right toward the direction of that man, the other man came up on my left, bumped me really hard and aggressively, and began a conversation with the man on my right. The man that bumped me did not say excuse me and stared at me as though he was challenging me to say something back. Although I don't know his name, I recognized the man on my left to be one of the Gulf County Sheriff's Office deputies.

In addition, I mailed Notice of Claim letters to the Dona Ana County Sheriff's Office, Las Cruces Police Department, New Mexico State Police, and Third Judicial District Attorney's Office on October 13, 2014. I am not sure what the status of those investigations are right now. But that event seemed to have been a catalyst for my electronic harassment being ratcheted up to the point of unbearable.

Over time, I have been collecting individuals' license plates that have been following me. As previously stated, some of these have already been transferred to Altrus Campbell via text message to [REDACTED] and email. The only person that I can personally identify that was stalking me in Las Cruces, NM is Elaine Lara, who resides at [REDACTED]. On November 14, 2014, I got hit with a directed energy weapon. It is difficult to explain exactly what this feels

like. I was also stalked by a senior-level, law enforcement officer in the Dona Ana County Sheriff's Office. Unfortunately, I cannot remember his name. He is a Hispanic male that appears to be in his late 40s or early 50s, and I know that he has a teenage son that plays football. In one discussion that we had, he stated that he worked between two candidates for sheriff on the organization chart, Captain Buckingham and Kent Yalkut. His name is either Paul Nevarez or Greg Garland. I can't remember. As I previously stated, I wish that I had done a better job at keeping records of the harassment that I have endured, but this is the best that I have.

I asked her why she covered it. After I asked her that, she looked at me very surprised and swore that it was a mistake. Then she stamped restricted on the front of the envelope. But when the postage paid label printed, she covered the restricted stamp up, so I had to ask her again about covering up the "restricted" portion. And she stamped it again. In the midst of this craziness, I decided to take her photograph.

NOTES FOR MY PERSONAL STORY AS A TARGETED INDIVIDUAL – PART 1

I. Reason for the Video

- A. Heavy heart that I make this video
- B. Victim of **covert harassment** through **electronic harassment** and **gang stalking**
- C. Thousands of people in the United States are victims—known as targeted individuals
 - i. Google or YouTube targeted individuals and gang stalking and you'll find several victims that tell stories similar to the one you'll hear today

II. Gang Stalking Goals Generally

- A. The goal of gang stalking is to literally make a targeted individual **destitute and drive them insane**
- B. They employ various tactics to accomplish this goal
 - i. People will **follow you around in public places**—shopping, on your way to work, as sick as the may sound, I've even had people follow me into church functions
 - ii. They employ isolation tactics.
 - a) Convince your family, friends, neighbors, and coworkers through **payment, lies** (such as falsely accusing you of committing a crime) that they should keep an eye on you, and **blackmail** for people that actually are doing something wrong—that's right they actually employ criminals to help in your harassment
 - To the targeted individual that has not yet discovered they are a targeted individual, this experience is very troubling because you just notice that people are watching you and don't know why
 - There's a saying that "people will do anything for money," and if they are doing it based on a lie, then they think they're doing something positive rather than participating in debilitating a person
 - b) Eventually, due to the targeted individual's own fear and apprehension from these experiences and the lies told to the targeted individual's acquaintances, the targeted individual finds himself alone

III. Gang Stalking Methods

A. Anchoring

- i. Try to convince the targeted individual that a **particular person or group** is doing the gang stalking—neighbors, coworkers, etc.
 - a) For me, control panel stalkers **tried to convince me that my neighbors** were actually the ones stalking me, and they were very successful at this for about two

months. Because I could hear someone describing what I was doing inside my apartment, I literally thought my neighbor above me had somehow installed a video camera in my home

- This was, of course, **before I knew I was a targeted individual or what a targeted individual was**

B. Brighting

- i. This method can be one of the most irritating of all. When you are driving at night, you will encounter several cars that turn their bright lights on you when they are tailgating, in oncoming traffic, or passing you.
 - a) Now, of course, it is natural that you will encounter a vehicle now and again where the person has forgotten to click their brights off or is missing a headlight and using their brights to hide that fact, but with brighting, this **will happen about ten times in one trip** in the vehicle
- ii. Another brighting technique is when they **flash brights into the windows of your home**. Individuals will frequently pull into your driveway or near your apartment window, shining their lights directly into your home.
 - a) Again, one can expect this to happen every once in awhile by happenstance, but when brighting is being employed, it will **happen several times in one night**

C. Noise Campaign

- i. This can be just as irritating as brighting. Basically, the targeted individual is subjected to a constant bout of noise to **keep them on edge**, and more importantly, **prevent them from sleeping**. A lack of sleep, as we all know, makes a person **edgy, agitated, and full of stress**
 - a) **Loud music** by neighbors
 - b) **Cars passing** by at rapid paces and blowing their **car horns**
 - c) Neighbors **screaming and talking loudly** near your home
 - Again, others are convinced to do this based on payment, blackmail, and lies that you have done something wrong or that you're crazy
 - d) Craziest tactic involved in a noise campaign is utilization of **machine-generated sounds** (e.g., dog barks, chickens calling, duck calls, etc.)
- ii. My personal experience with a noise campaign is what made me realize that I was a **targeted individual**. I traveled to Houston, TX to get away from Las Cruces for awhile because I literally was starting to question my own sanity. While I was in Houston, I was staying at my friend, **Kimberly Snagg's mom's home**.
 - a) **Every ten minutes a car came flying** down this **residential street** making all sorts of noise and about **every 30 minutes a horn was blowing**. Having been at this house several times and knowing that only old people lived in the neighborhood, I knew that this was unusual.
 - b) What was even more puzzling was that I started hearing the **"cock-a-doodle-doo"** of

a rooster coming from one of the houses in the back. It was the exact same cock-a-doodle-doo **without any variation** to it; it was happening at **4pm in the afternoon**; and it **continued literally for hours** on end.

iii. It was this experience that made me realize that maybe there was more to my being followed than I had previously imagined

iv. Some of my other experiences with a noise campaign

a) I was staying at my friend, **Monica Johnson's home**. And I am certain that they convinced the Johnson family to participate. While I hate to spill the beans on family, Monica's husband, **Marshall, smokes marijuana**. I am convinced that they **blackmailed** them into participating in my harassment. This of course was not the first time that I had visited them. But on this occasion, everyone was being extremely noisy, and **at about 3am**, Monica came into the living room, where I was sleeping on the couch, yelling about her daughter, **Brittany's, car being repossessed**. Also, there were **three TVs** on in the house at **full blast** throughout the night.

b) In Las Cruces, my **neighbors constantly made noise**—I went a **1.5 years with no such noise**, then all of a sudden it was nonstop.

c) **One night in particular**, the neighbor above me was playing his music extremely loud, so I put **ear plugs** in. Moments after I put earplugs in, from the neighbor's apartment next to me—the headboard of my bed literally sits on her wall—I started hearing **extremely loud sex sounds**. Again, I have lived in this apartment for **1.5 years without any such noises**, but on this night, it was extremely loud.

D. Ghosting

i. I didn't experience ghosting, but this technique involves **rearranging a targeted individual's things**—furniture while they're gone, taking clothes out of their belongings at the laundry mat, moving lawn decoration, and stuff like that

a) **Paranoia; question own sanity**

E. Mimicry

i. This involves a stalker encountering the targeted individual, and the **stalker literally mimics every movement the target makes**.

a) I only **experienced this once** when I was at the gas station in Wewa. He comes out from behind the pump and starts waiving. This particular stalker was **wearing dark shades and staring directly at me to make his presence known**. I started **washing my windows**. When I was washing the front, he was washing his front and looking directly at me. When I moved to a side window, he moved to a side window and was looking directly at me. It was very irritating and frustrating

F. Sensitization

i. This refers to an **association of a particular stimuli with harassment**. If the target encounters stalkers wearing blue baseball caps, for example, the target will start to associate their harassment to people wearing blue baseball caps.

a) The sensitization technique that was used on me was **dark sunglasses**. The goal was to make me believe that everyone wearing dark sunglasses was out to harass me. While I definitely knew that was not the case, I still **found myself looking curiously at people wearing dark sunglasses**.

G. Mobbing

- i. This refers to a stalking technique in which the target encounters **several individuals stalking them at once**. This typically happens when the target starts to realize that something more is going on or is in a frustrated state. It is **designed to scare the target**.
- a) This particular technique has happened to me on **numerous occasions**. Because I have a pretty **low anger threshold**, typically, when I have gotten upset about my experiences, that is when I experience mobbing. If I'm driving or in a store when I'm upset, **several individuals** come into my personal space at once or **several cars** (10 or so) will pass by all at once (**coupled with my stimuli of dark sunglasses**) with individuals wearing dark sunglasses and **looking directly at me** rather than watching the road.

H. Hacking

- i. This refers to **downloading of viruses and malware** on the targets phone and computer. This is used **both as a defense and for stalking**.
- a) My Experiences With Hacking
 - When I **first realized there was more going on** with my experiences than meets the eye, viruses and malware were downloaded onto my computer, which enabled them to have **remote access** to my computer. I would literally be working on my computer, and the **mouse would start moving on its own and clicking on things**.
 - One night, I was **trying to purchase a book by Renee Pittman Mitchell from Amazon** on my phone one night, and the **browser on my phone kept closing** on its own. My phone, of course, had **never done this before**.
 - When I first moved to Wewa, I got a job at **Taunton Family Children's Home**. During my first day on the job, my **work computer was compromised, and the mouse was moving on its own**. I was working on a **family law case** for a mother, whose kid was taken from her by the father, and they took control of my computer and **attempted to delete the family law document** that I had just finished to try and get the mother's child back.
 - After the family law document was almost deleted, I was **able to get the necessary anti-virus software to combat the hacking**.

I. Electronic Harassment (Sci-Fi Made Real);

- i. This technology is the **most creepy and frightening** weapon in the stalkers' arsenal.
- ii. This technology is detailed in **Dr. Robert Duncan's book, Project Soul Catcher: Secrets of Cyber and Cybernetic Warfare Revealed**
- iii. **Linchpin of the whole gang stalking program**

iv. Nanofibers

- a) Through nanotechnology and chemtrails, the control panel stalkers are able to **monitor and induce all sorts of things in a target**.

b) My Personal Story

- This technology has been the most troubling for me in dealing with the experience of being a target. v. **Psychotronic Weapons: Voice of God & Image Induction Weapons (Sci Fi Made Real)**

- This technology is discussed in **Dr. Duncan's book**. You may also find videos about it on **youtube** by searching for "Dr. Robert Duncan" or "Project Soul Catcher."
- This technology sounds absolutely crazy, **BUT IT IS REAL!** Through the use of **microwave radio frequency radiation**, control panel stalkers are able to literally **induce sound, including voice, into a target's cochlea** so that they hear voices. This technology is the **linchpin** of the entire gang stalking program:
 - To the targeted individual that does **not realize they are target or that this technology exists**, they start to believe that they are having a **schizophrenic or psychotic** episode. And if they **try to explain to someone else** that they are hearing voices, then that person will, of course, reach the same conclusion.
 - In essence, the person either thinks they are crazy or other people think the person is crazy. This **works in favor of the program always remaining a secret** because any target that attempts to speak out about this will instantly be **discredited as schizophrenic**. This also **further isolates** the target from acquaintances, friends, and loved ones. **BUT PLEASE REVIEW DR. DUNCAN'S TECHNOLOGY BEFORE YOU WRITE THIS OFF AS UNBELIEVABLE OR CRAZY!!!**
- With the image induction technology, which is based on the same bio-technological research as Voice of God Weapons, control panel stalkers are able to **induce images into a target's mind** (which is typically done while the target is **sleeping**). In addition, control panel stalkers are **able to see any images originating from the target's mind**—both **actual images** (what the target is actually looking at) and **fictional images** (images that the target is thinking about from memory or imagination)

IV. Effectiveness of Voice of God Weapons for the Overall Stalking Program

- A. Just as control panel stalkers can induce sound into a target's ear, control panel stalkers **can induce sound into a street-level stalker's ear**. In this way, control panel stalkers are able to easily **alert street-level stalkers** of the presence of a target and give them **direction as to how to interact** with the target without the target ever knowing. Dear Representative/Senator _____:

After hearing about the story of Targeted Individual Myron May and other targeted individuals, I have accepted the challenge to do what I can to make a difference. That's why I am urging you to pass a bill or resolution to begin an investigation into the targeting of United States citizens for the types of harassment outlined in my letter below:

Although not widely known by the public, targeted individuals endure a scheme of conduct designed to drive them over the edge mentally, physically, and emotionally. This scheme is referred to among the targeted individual community as "gang stalking." Gang Stalking is a systemic form of control, which seeks to control every aspect of a Targeted Individual's life. Gang stalking takes place outside in the community. It's called gang stalking because the target is followed around and placed under surveillance.

Gang Stalking Goals

The goals of gang stalking are to (a) silence an individual, (b) drive a victim insane and possibly to the point of suicide, and (c) destroy the victim's reputation and believability—as the person will be viewed as mentally ill if they complain or report such abuse. Gang stalking may also be used to force an individual to move or leave an area.

Motivations for Gang Stalking

The motivations for gang stalking vary widely. Three of the most common are as follows:

- Being a corporate or government whistle blower (particularly if you are exposing conduct that is unbecoming of law enforcement);
- Revenge for getting away with a criminal offense;
- Knowing too much about gang stalking itself—because you become a threat to exposure

Who Are The Stalkers?

For the most part, stalkers are everyday citizens that are usually acting under some type of guise (e.g., that they are doing something positive for the community; a false accusation that the targeted individual is under investigation for a crime). Other stalkers, however, are simply paid to harass a targeted individual. Sadly, many of these gang stalkers are involved in law enforcement.

Examples of Gang Stalking Harassment

Here are some of the stalking activities that targeted individuals have to endure: slashed tires, threatening phone calls, hangup calls, verbal assaults by strangers, property damage, death threats, peeping toms, being followed on foot and by vehicle, and character assassination among family, friends, neighbors, and coworkers.

Tactics Used by Stalkers

Anchoring

A technique employed by stalkers to persuade the targeted individual that a particular group is responsible for the abuse—neighbors, racial-ethnic group, etc. The goal is to trick the targeted individual into thinking an innocent bystander is the culprit of their harassment and compel the targeted individual into verbally or physically assaulting that person.

Brighting

Brighting involves the practice of repetitive flashing of a car's high beam headlights at a targeted individual. The targeted individual is flashed an inordinate amount of times from either a tailgating, passing, or oncoming vehicle. Brighting also occurs when bright lights are flashed into a targeted individual's home windows.

Electronic Harassment

Electronic harassment is the use of technological devices to spy on or cause harm to targeted individuals (e.g., exposure to high electromagnetic fields, microwave radiation, etc.). A frequent form of harassment involves beaming a low frequency tone into a targeted individual's area, which over time causes sleep deprivation, agitation, and stress. A great deal of this research is highlighted in a book written by the pioneer of electronic harassment, Dr. Robert Duncan, which is entitled "Project Soul Catcher: Secrets of Cyber and Cybernetic Warfare Revealed." Other prominent individuals in the field include Dr. Nick Begiche, Dr. John Hall, and Dr. Terry Andersen. In addition to electronic harassment, stalkers utilize nanofibers to track targeted individuals.

Ghosting

Ghosting refers to the practice of rearranging or moving a targeted individual's personal belongings to make the targeted individual question his/her sanity (e.g., moving home furniture, lawn decorations, desk decorations, etc.).

Mimicry

Mimicry is a specialized form of harassment in which the stalkers imitate every movement made by the victim.

Mobbing

Mobbing is a term that describes intense group bullying. Several stalkers descend upon a targets area in the same time period. In these instances, gang stalkers are not as discrete because they want to make their presence known to the targeted individual.

Noise Campaign

A noise campaign is an orchestrated effort to produce stress in a targeted individual by prolonged exposure to noise (e.g., neighbors playing loud music, cars passing at rapid paces, vehicle horns blowing, technological devices to induce dogs to bark, etc.).

Sensitization

Sensitization is a psychological term referring to the forced association between a stimuli and a corresponding reaction. For example, if a targeted individual is frequently harassed by people wearing blue baseball caps or sunglasses, over time, the targeted individual will believe that anyone wearing a blue baseball cap or sunglasses is a stalker coming to harass them.

Gas-Lighting

Gas lighting refers to presentation of false information for the purpose of making victims doubt their own memory, perception, and sanity.

Hacking

Hacking generally refers to the downloading of viruses and malware as well as gaining remote access to a targeted individual's electronic devices. After gaining such access, stalkers are able to delete files, modify files, and contemporaneously interfere with a target while he or she is working.

It is my hope that you will accept the challenge as I have. Again, I strongly urge you to consider passing a bill or resolution to conduct an investigation into the harassment outlined in my letter above. Thank you for your consideration.

Dear Representative/Senator _____:

After hearing about the story of Targeted Individual Myron May and other targeted individuals, I have accepted the challenge to do what I can to make a difference. That's why I am urging you to pass a bill or resolution to begin an investigation into the targeting of United States citizens for the types of harassment outlined in my letter below:

Although not widely known by the public, targeted individuals endure a scheme of conduct designed to drive them over the edge mentally, physically, and emotionally. This scheme is referred to among the targeted individual community as "gang stalking." Gang Stalking is a systemic form of control, which seeks to control every aspect of a Targeted Individuals life. Gang stalking takes place outside in the community. It's called gang stalking because the target is followed around and placed under surveillance.

Gang Stalking Goals

The goals of gang stalking are to (a) silence an individual, (b) drive a victim insane and possibly to the point of suicide, and (c) destroy the victim's reputation and believability—as the person will be viewed as mentally ill if they complain or report such abuse. Gang stalking may also be used to force an individual to move or leave an area.

Motivations for Gang Stalking

The motivations for gang stalking vary widely. Three of the most common are as follows:

- Being a corporate or government whistle blower (particularly if you are exposing conduct that is unbecoming of law enforcement);
- Revenge for getting away with a criminal offense;
- Knowing too much about gang stalking itself—because you become a threat to exposure

Who Are The Stalkers?

For the most part, stalkers are everyday citizens that are usually acting under some type of guise (e.g., that they are doing something positive for the community; a false accusation that the targeted individual is under investigation for a crime). Other stalkers, however, are simply paid to harass a targeted individual. Sadly, many of these gang stalkers are involved in law enforcement.

Examples of Gang Stalking Harassment

Here are some of the stalking activities that targeted individuals have to endure: slashed tires, threatening phone calls, hangup calls, verbal assaults by strangers, property damage, death threats, peeping toms, being followed on foot and by vehicle, and character assassination among family, friends, neighbors, and coworkers.

Tactics Used by Stalkers

Anchoring

A technique employed by stalkers to persuade the targeted individual that a particular group is responsible for the abuse—neighbors, racial-ethnic group, etc. The goal is to trick the targeted individual into thinking an innocent bystander is the culprit of their harassment and compel the targeted individual into verbally or physically assaulting that person.

Brighting

Brighting involves the practice of repetitive flashing of a car's high beam headlights at a targeted individual. The targeted individual is flashed an inordinate amount of times from either a tailgating, passing, or oncoming vehicle. Brighting also occurs when bright lights are flashed into a targeted individual's home windows.

Electronic Harassment

Electronic harassment is the use of technological devices to spy on or cause harm to targeted individuals (e.g., exposure to high electromagnetic fields, microwave radiation, etc.). A frequent form of harassment involves beaming a low frequency tone into a targeted individual's area, which over time causes sleep deprivation, agitation, and stress. A great deal of this research is highlighted in a book written by the pioneer of electronic harassment, Dr. Robert Duncan, which is entitled "Project Soul Catcher: Secrets of Cyber and Cybernetic Warfare Revealed." Other prominent individuals in the field include Dr. Nick Begiche, Dr. John Hall, and Dr. Terry Andersen. In addition to electronic harassment, stalkers utilize nanofibers to track targeted individuals.

Ghosting

Ghosting refers to the practice of rearranging or moving a targeted individual's personal belongings to make the targeted individual question his/her sanity (e.g., moving home furniture, lawn decorations, desk decorations, etc.).

Mimicry

Mimicry is a specialized form of harassment in which the stalkers imitate every movement made by the victim.

Mobbing

Mobbing is a term that describes intense group bullying. Several stalkers descend upon a targets area in the same time period. In these instances, gang stalkers are not as discrete because they want to make their presence known to the targeted individual.

Noise Campaign

A noise campaign is an orchestrated effort to produce stress in a targeted individual by prolonged exposure to noise (e.g., neighbors playing loud music, cars passing at rapid paces, vehicle horns blowing, technological devices to induce dogs to bark, etc.).

Sensitization

Sensitization is a psychological term referring to the forced association between a stimuli and a corresponding reaction. For example, if a targeted individual is frequently harassed by people wearing blue baseball caps or sunglasses, over time, the targeted individual will believe that anyone wearing a blue baseball cap or sunglasses is a stalker coming to harass them.

Gas-Lighting

Gas lighting refers to presentation of false information for the purpose of making victims doubt their own memory, perception, and sanity.

Hacking

Hacking generally refers to the downloading of viruses and malware as well as gaining remote access to a targeted individual's electronic devices. After gaining such access, stalkers are able to delete files, modify files, and contemporaneously interfere with a target while he or she is working.

It is my hope that you will accept the challenge as I have. Again, I strongly urge you to consider passing a bill or resolution to conduct an investigation into the harassment outlined in my letter above. Thank you for your consideration.

MY EXPERIENCES AS A TARGETED INDIVIDUAL

My deepest regret is that I did not make a more diligent effort of documenting my experiences as a targeted individual along the way; however, this document is my feeble attempt at recounting my experiences thus far. First off, to anyone that may read this document, take a brief moment to pray for my soul. What I am about to do I have deep regret for; however, I feel that my options are extremely limited. Because I am a targeted individual, everything has been taken away from me. I have literally been robbed of life through psychological, financial, and emotional hardship.

I first realized that I was a target while I was working as an Assistant District Attorney for the Third Judicial District Attorney's Office in Dona County, New Mexico. I tried going to the police about my situation. On or about September 7, 2014, I went to the Las Cruces Police Department to make a report of my experiences. The interior of the LCPD office was locked, but there was a phone in the vestibule, which dispatch answered. I informed dispatch that I wanted to make a police report, and they sent an officer out to my location. I believe the officer's name was Kenneth Davis (Caucasian male that appeared to be in his 20s). The officer took notes of my experience; however, no police report was ever made. Nevertheless, there should be a record of my phone call with Dispatch. That morning, I got invited to the gun range by my girlfriend's friend's husband, Robert Kitcey (rkitcey@gmail.com). When I met up with him later that morning at Starbucks, I informed him and another guy that was with him of the police report that I had just made. If you need to get in contact with Robert, you can contact my ex-girlfriend, Danielle Nixon [REDACTED]. I don't remember the other guy's name, but he is an engineer from Michigan (Caucasian male in his late 40s or early 50s), and his wife's name is Betty (Kenyan woman who appears to be in her early 40s, with a bald haircut).

My apartment was broken into, and my phone was tampered with. I started being followed by various individuals in unmarked cars. And on one occasion, I was followed by an individual in an LCPD sport utility vehicle cruiser. Through electronic harassment, these individuals convinced me that I was guilty of a crime. As a result, I attempted to turn myself in at the Dona Ana County Detention Center on three separate occasions. I was literally escorted to the jail by about ten cars; however, no one went inside the jail with me. Each time I attempted to turn myself in, the cars waited in the parking lot (watching me go inside the jail). But the jail informed me that they had no paperwork for me. Then, each time I left the jail after being turned away, the cars that escorted me into the jail were gone.

I continued to be followed. I informed my girlfriend, Danielle Nixon, who resides in Las Cruces [REDACTED], and my friend, Kirton, who also resides in Las Cruces [REDACTED] of these instances. Because I was an over-achiever in my position, I frequently worked late. When I was in the office alone after hours, I would consistently see individuals peeking around corners at me. As a result of this harassment, I eventually resigned from my Assistant District Attorney position and traveled to Houston, Texas to get my old job back. I met with my old boss, Alfonso Kennard, on the evening of Friday, October 10, 2014, to discuss rejoining his law firm, Kennard Law, P.C. as an Associate. On that evening, Kennard offered me my old job back at a base salary of \$50,000 per year plus 20% commissions on all settlements or judgment obtained on my cases.

After we had reached terms on that agreement, Kennard called his driver, Randy [stout, Caucasian male who appeared to be in his late 40s], to take us to another place because we had been drinking and should not have been driving. Before Randy arrived, Randy's friend Edwin arrived. It was unclear to me how Edwin could have possibly known who we were, but he approached Kennard and I at the bar and claimed that he was there to meet with Randy. When Randy arrived, we had one last drink. As we were leaving, I went to my car to retrieve my ID and wallet. I returned to find Randy and Edwin whispering to Kennard. When I returned, everyone acted very unusual toward me; it was not the same jovial conversation that had preceded this occurrence. Then, we loaded up into Randy's SUV to go to the next location. As we were driving to the next location, Kennard leaned over and asked me, "if I wanted to take a bump"—suggesting that if I wanted to take a bump of cocaine Randy or Edwin could get it for me. I vehemently assured Kennard that I did not want to take a bump. Nor had I ever taken a bump.

On Saturday, Kennard would not respond to my phone calls or text messages, which was strange because for the two days prior to that he had been very responsive. Kennard's distance did not arise until after his private discussion with Randy and Edwin. As a result of this strange behavior, I informed Kennard via text message that I may have to depose him in a lawsuit. Thereafter, Kennard called me to arrange another meeting. According to Kennard, he wanted me to discuss my re-joining the firm with his partner, Terrance Robinson. We arranged a meeting for that Monday, October 14, 2014. On Monday, we met at the A-loft, which is located at 5415 Westheimer Road next to Kennard's law office. While there, we had drinks. Kennard and Robinson had two drinks, and I had one drink. Then, we went across the street to The West End Bar &

Grille, which is located at 5320 Westheimer Road to have a meal. Shortly after we arrived, Randy showed up and suggested that we go to another restaurant down the street. Because Kennard agreed to pick up the dinner tab, I agreed to go. At the restaurant, Kennard kept insisting that I join him outside to discuss matters with him. He again brought up the conversation about me taking a bump of cocaine, and I again insisted to him that I have never taken cocaine.

After dinner, Randy dropped me off at my car, which was parked near The West End. The following day, I attempted to call Kennard, but my phone number was blocked. I attempted to call Kennard a couple of times after that, but my phone number was still blocked. While I do not have last names for Randy, the driver, or Edwin, I am certain that whatever was said in that whisper cost me my job. This situation was all a part of an elaborate scheme to put me in financial jeopardy, thereby making me more amenable to harassment and less able to fight the issue. Upset and jobless, I returned to Las Cruces to continued harassment and being followed.

On the morning when I was leaving Houston, my tire was punctured and flattened while in the driveway at [REDACTED] (residence of Monica Johnson), where I was staying. When I returned to Las Cruces, I had to take my tire to On Sale Tires to have it repaired. There should be a record of that repair with On Sale Tires. Further, after returning to Las Cruces, I was subjected to a constant noise campaign designed to induce sleep deprivation in me. My neighbors played loud music, screamed, and people frequently made noise right outside my windows. Not only did this happen at night time, but this happened during the day as well. Maintenance staff, which almost never worked outside my window previously, worked and made noise right outside my window everyday.

In addition through electronic harassment, my life was constantly threatened. Fearing for my life, I decided to pack my things and move back home to Wewahitchka, FL. As I was loading my Uhaul to pack my things on October 21, 2014, my life continued to be threatened through electronic harassment. Additionally, as I was loading my Uhaul, there was a middle-aged man parked in the arroyo across the fence from my apartment complex (Quail Ridge Apartments - 251 North Roadrunner Parkway). He was driving a gray Dodge Durango 4 x 4 with a camper shell that had a Colorado License Plate, 285 YPI. This man got out of the driver-side of his truck, removed a blanket from the camper shell, and unsheathed a firearm from the blanket. Then, the most frightening thing happened. The man pointed this firearm at me, as I stood inside the trailer portion of the Uhaul truck. I jumped off the truck, ran towards my apartment, and called 911. There should be a record of this call with dispatch.

While officers were en route to my location, the man wrapped the firearm back in the blanket and put it in the right side of the camper shell. Five officers responded to the scene of Quail Ridge. These officers were acting very aggressively towards me as though I was the assailant and not the complainant-victim. Unfortunately, I was only able to get four of the officers' names: Officer Shadd; Officer Frank Gomez; Lieutenant W.C. Jackson; and Officer Guerra (who aggressively refused to give me his first name but whose badge number was L650). Officers claimed that they searched the mysterious man, but I watched this alleged search with my own eyes. They never searched his person. Nor did they even go to the right side of the vehicle, where I saw this man place the gun. They merely peeked inside the driver-side of the pickup truck, which should hardly be characterized as a search.

After talking with the man a little while longer, they came over to me and claimed that the man did not have a gun and that they had conducted a thorough search of his person and the vehicle. The continued to speak to me very aggressively and insisted that this man had driven from Colorado to Las Cruces, New Mexico to survey the land that he was on. The land that he was on is located directly behind Golden Mesa Las Cruces Independent Senior Living Community. If a survey of that property was requested, there should be documentation somewhere. I am certain that if you search, you won't find any such documentation. It does not even make sense that someone would travel all the way from Colorado to conduct such a survey, especially in light of the fact that you have to be licensed in New Mexico to conduct surveys. While it's certainly possible that this man could have been licensed in New Mexico, it is unlikely that Golden Mesa or the surface owners of the property behind Golden Mesa would not have simply hired a New Mexico-licensed surveyor. This experience, particularly the aggressive behavior of the officers, convinced me that law enforcement was very much involved in my harassment.

I am not sure what information was given to the leasing office at my apartment complex, but shortly after this incident, I received a letter on my door informing me that it was a notice to vacate my apartment. There should be a record of this notice and/or any interactions with law enforcement in the Quail Ridge leasing office. The harassment did not stop on this day with that incident. My life continued to be threatened via electronic harassment. I was literally threatened to leave Las Cruces immediately. As a result, I left several of my belongings in my apartment at Quail Ridge, which was

Apartment 1407. The leasing office should likewise have information regarding me leaving my belongings on both the interior and exterior of my apartment. One of the things that I left in my apartment was my old cell phone (a red Samsung Galaxy S3). I had gathered several license plate numbers in this phone, but because I was told through the electronic harassment that I would be left alone if I left Las Cruces and left my phone in the apartment, I did. I, however, had forwarded some of this license plate information to Altrus Campbell via text message and email. In addition, I gathered some license plate information in the iPhone that was issued to me by the Third Judicial District Attorney's Office. I sent a Preservation of Evidence email to John Willis, IT personnel with the Third Judicial District Attorney's Office, on October 21, 2014, in reference to preserving the information in that cell phone.

While traveling from Las Cruces, NM to Wewahitchka, FL, I was repeatedly tailgated and cut off by both patrol cars as well as regular cars. I was almost run off the road at one point in Kerr County, TX. Further, while I was in Kerr County, Texas, I was pulled over and officers searched my vehicle for no reason whatsoever. I did not give officers any consent to search my vehicle. Nor did they show me a warrant. They made me get out of the vehicle. They handcuffed me, and I stood in the heat with no shoes on for approximately three hours. Several officers were present, including Chief Deputy Clay Barton and Deputy Eli Garcia. There were about six more officers, but unfortunately due to the aggressiveness and hostility that the officers showed me, I was not able to get the others' information. Nevertheless, there should be Kerr County dispatch reports of the other officers that were involved. The officers held me there while a K-9 unit arrived from another county. My belongings were packed in plastic bins, and they literally opened every single plastic bin and searched it on the false claim that the K-9 had alerted to something inside the truck. The dog seemed more interested in the toy that the dog's handler was holding than anything in my Uhaul, and of course, they never found any narcotics.

I took a rest break in Houston, Texas on my way to Florida. I stopped at the residence of Monica Johnson again. While there, the noise campaign continued. In fact, they recruited the Johnson family to participate in my harassment. Marciel (pronounced Marshall) is typically a quiet and reserved person, but he was continuously speaking very loudly and screaming throughout the evening. I was sleeping on the couch in the living room. While he was in his bedroom downstairs, he had his bedroom television blaring. I believe that they were recruited to participate in my harassment based on a threat of Marshall going to jail for possession of marijuana. At about 3:00 am that morning, while I was sleeping, Monica came out of the room screaming about her daughter, Britney's car being repossessed. While it's certainly plausible that Britney's car, a red SUV, could have been repossessed, Monica went on and on about the repossession—slamming doors, dropping things, and yelling at the top of her lungs. Eventually, realizing that I was not going to get any sleep in that house, I got up and continued my journey to Florida.

Of course, the electronic and other harassment continued for the duration of my trip. I was continuously cut off and tailgated in traffic the entire way. I eventually made it to Florida. When I got to Wewahitchka, Florida (and since I have been in Florida), the harassment has continued, mainly through electronic (Voice of God – see Dr. Robert Duncan) harassment. This harassment has been very debilitating and impactful. They have recruited other individuals to participate in harassing me, including Buddy Parker (older, Caucasian male that is married to Ann Parker), Clifford Jones (son of Louise Jones), Roy Myers (who is my cousin and the brother of Michael Myers and Melody Williams), and Demetrious (not sure what his last name is, but he is the brother of Warren Bowers). There have been others that have been sent out to stalk me as well. Unfortunately, I don't know these other individuals' names. On one occasion, about two weeks ago, I was in Rich's IGA standing in front of a three-foot, front-facing section of Little Debbie snack cakes. Two gentlemen came into the store and walked directly over to me. One of the gentlemen stood inordinately close to me, very much in my personal space. When I turned to my right toward the direction of that man, the other man came up on my left, bumped me really hard and aggressively, and began a conversation with the man on my right. The man that bumped me did not say excuse me and stared at me as though he was challenging me to say something back. Although I don't know his name, I recognized the man on my left to be one of the Gulf County Sheriff's Office deputies.

In addition, I mailed Notice of Claim letters to the Dona Ana County Sheriff's Office, Las Cruces Police Department, New Mexico State Police, and Third Judicial District Attorney's Office on October 13, 2014. I am not sure what the status of those investigations are right now. But that event seemed to have been a catalyst for my electronic harassment being ratcheted up to the point of unbearable.

Over time, I have been collecting individuals' license plates that have been following me. As previously stated, some of these have already been transferred to Altrus Campbell via text message to [REDACTED] and email. The only person that I can personally identify that was stalking me in Las Cruces, NM is Elaine Lara, who resides [REDACTED]. On November 14, 2014, I got hit with a directed energy weapon. It is difficult to explain exactly what this feels

like. I was also stalked by a senior-level, law enforcement officer in the Dona Ana County Sheriff's Office. Unfortunately, I cannot remember his name. He is a Hispanic male that appears to be in his late 40s or early 50s, and I know that he has a teenage son that plays football. In one discussion that we had, he stated that he worked between two candidates for sheriff on the organization chart, Captain Buckingham and Kent Yalkut. His name is either Paul Nevarez or Greg Garland. I can't remember. As I previously stated, I wish that I had done a better job at keeping records of the harassment that I have endured, but this is the best that I have.

I asked her why she covered it. After I asked her that, she looked at me very surprised and swore that it was a mistake. Then she stamped restricted on the front of the envelope. But when the postage paid label printed, she covered the restricted stamp up, so I had to ask her again about covering up the "restricted" portion. And she stamped it again. In the midst of this craziness, I decided to take her photograph.

 - ii. They employ isolation tactics.
 - a) Convince your family, friends, neighbors, and coworkers through **payment, lies** (such as falsely accusing you of committing a crime) that they should keep an eye on you, and **blackmail** for people that actually are doing something wrong—that's right they actually employ criminals to help in your harassment
 - To the targeted individual that has not yet discovered they are a targeted individual, this experience is very troubling because you just notice that people are watching you and don't know why
 - There's a saying that “people will do anything for money,” and if they are doing it based on a lie, then they think they're doing something positive rather than participating in debilitating a person
 - b) Eventually, due to the targeted individual's own fear and apprehension from these experiences and the lies told to the targeted individual's acquaintances, the targeted individual finds himself alone

III. Gang Stalking Methods

A. Anchoring

- i. Try to convince the targeted individual that a **particular person or group** is doing the gang stalking—neighbors, coworkers, etc.
 - a) For me, control panel stalkers **tried to convince me that my neighbors** were actually the ones stalking me, and they were very successful at this for about two

months. Because I could hear someone describing what I was doing inside my apartment, I literally thought my neighbor above me had somehow installed a video camera in my home

- This was, of course, **before I knew I was a targeted individual or what a targeted individual was**

B. Brighting

- i. This method can be one of the most irritating of all. When you are driving at night, you will encounter several cars that turn their bright lights on you when they are tailgating, in oncoming traffic, or passing you.
 - a) Now, of course, it is natural that you will encounter a vehicle now and again where the person has forgotten to click their brights off or is missing a headlight and using their brights to hide that fact, but with brighting, this **will happen about ten times in one trip** in the vehicle
- ii. Another brighting technique is when they **flash brights into the windows of your home**. Individuals will frequently pull into your driveway or near your apartment window, shining their lights directly into your home.
 - a) Again, one can expect this to happen every once in awhile by happenstance, but when brighting is being employed, it will **happen several times in one night**

C. Noise Campaign

- i. This can be just as irritating as brighting. Basically, the targeted individual is subjected to a constant bout of noise to **keep them on edge**, and more importantly, **prevent them from sleeping**. A lack of sleep, as we all know, makes a person **edgy, agitated, and full of stress**
 - a) **Loud music** by neighbors
 - b) **Cars passing by** at rapid paces and blowing their **car horns**
 - c) Neighbors **screaming and talking loudly** near your home
 - Again, others are convinced to do this based on payment, blackmail, and lies that you have done something wrong or that you're crazy
 - d) Craziest tactic involved in a noise campaign is utilization of **machine-generated sounds** (e.g., dog barks, chickens calling, duck calls, etc.)
- ii. My personal experience with a noise campaign is what made me realize that I was a **targeted individual**. I traveled to Houston, TX to get away from Las Cruces for awhile because I literally was starting to question my own sanity. While I was in Houston, I was staying at my friend, **Kimberly Snagg's mom's home**.
 - a) **Every ten minutes a car came flying down this residential street** making all sorts of noise and about **every 30 minutes a horn was blowing**. Having been at this house several times and knowing that only old people lived in the neighborhood, I knew that this was unusual.
 - b) What was even more puzzling was that I started hearing the **"cock-a-doodle-doo"** of

a rooster coming from one of the houses in the back. It was the exact same cock-a-doodle-doo **without any variation** to it; it was happening at **4pm in the afternoon**; and it **continued literally for hours** on end.

iii. It was this experience that made me realize that maybe there was more to my being followed than I had previously imagined

iv. Some of my other experiences with a noise campaign

- a) I was staying at my friend, **Monica Johnson's home**. And I am certain that they convinced the Johnson family to participate. While I hate to spill the beans on family, Monica's husband, **Marshall, smokes marijuana**. I am convinced that they **blackmailed** them into participating in my harassment. This of course was not the first time that I had visited them. But on this occasion, everyone was being extremely noisy, and **at about 3am**, Monica came into the living room, where I was sleeping on the couch, yelling about her daughter, **Brittany's, car being repossessed**. Also, there were **three TVs** on in the house at **full blast** throughout the night.
- b) In Las Cruces, my **neighbors constantly made noise**—I went a **1.5 years with no such noise**, then all of a sudden it was nonstop.
- c) **One night in particular**, the neighbor above me was playing his music extremely loud, so I put **ear plugs** in. Moments after I put earplugs in, from the neighbor's apartment next to me—the headboard of my bed literally sits on her wall—I started hearing **extremely loud sex sounds**. Again, I have lived in this apartment for **1.5 years without any such noises**, but on this night, it was extremely loud.

D. Ghosting

- i. I didn't experience ghosting, but this technique involves **rearranging a targeted individual's things**—furniture while they're gone, taking clothes out of their belongings at the laundry mat, moving lawn decoration, and stuff like that
 - a) **Paranoia; question own sanity**

E. Mimicry

- i. This involves a stalker encountering the targeted individual, and the **stalker literally mimics every movement the target makes**.
 - a) I only **experienced this once** when I was at the gas station in Wewa. He comes out from behind the pump and starts waiving. This particular stalker was **wearing dark shades and staring directly at me to make his presence known**. I started **washing my windows**. When I was washing the front, he was washing his front and looking directly at me. When I moved to a side window, he moved to a side window and was looking directly at me. It was very irritating and frustrating

F. Sensitization

- i. This refers to an **association of a particular stimuli with harassment**. If the target encounters stalkers wearing blue baseball caps, for example, the target will start to associate their harassment to people wearing blue baseball caps.
 - a) The sensitization technique that was used on me was **dark sunglasses**. The goal was to make me believe that everyone wearing dark sunglasses was out to harass me. While I definitely knew that was not the case, I still **found myself looking curiously at people wearing dark sunglasses**.

G. Mobbing

- i. This refers to a stalking technique in which the target encounters **several individuals stalking them at once**. This typically happens when the target starts to realize that something more is going on or is in a frustrated state. It is **designed to scare the target**.
 - a) This particular technique has happened to me on **numerous occasions**. Because I have a pretty **low anger threshold**, typically, when I have gotten upset about my experiences, that is when I experience mobbing. If I'm driving or in a store when I'm upset, **several individuals** come into my personal space at once or **several cars** (10 or so) will pass by all at once (**coupled with my stimuli of dark sunglasses**) with individuals wearing dark sunglasses and **looking directly at me** rather than watching the road.

H. Hacking

- i. This refers to **downloading of viruses and malware** on the targets phone and computer. This is used **both as a defense and for stalking**.
 - a) My Experiences With Hacking
 - When I **first realized there was more going on** with my experiences than meets the eye, viruses and malware were downloaded onto my computer, which enabled them to have **remote access** to my computer. I would literally be working on my computer, and the **mouse would start moving on its own and clicking on things**.
 - One night, I was **trying to purchase a book by Renee Pittman Mitchell from Amazon** on my phone one night, and the **browser on my phone kept closing on its own**. My phone, of course, had **never done this before**.
 - When I first moved to Wewa, I got a job at **Taunton Family Children's Home**. During my first day on the job, my **work computer was compromised, and the mouse was moving on its own**. I was working on a **family law case** for a mother, whose kid was taken from her by the father, and they took control of my computer and **attempted to delete the family law document** that I had just finished to try and get the mother's child back.
 - After the family law document was almost deleted, I was **able to get the necessary anti-virus software to combat the hacking**.

I. Electronic Harassment (Sci-Fi Made Real);

- i. This technology is the **most creepy and frightening** weapon in the stalkers' arsenal.
- ii. This technology is detailed in **Dr. Robert Duncan's book, Project Soul Catcher: Secrets of Cyber and Cybernetic Warfare Revealed**
- iii. **Linchpin of the whole gang stalking program**
- iv. Nanofibers
 - a) Through nanotechnology and chemtrails, the control panel stalkers are able to **monitor and induce all sorts of things in a target**.

- **Bodily functions, pain receptors, and stress hormones**
- Through this technology, a target's **heart rate** can be sped up
- **Direct energy weapons**

b) My Personal Story

- This technology has been the most troubling for me in dealing with the experience of being a target. I have been **induced to have what I thought were panic attacks on two separate occasions** because my heart rate was moving so rapidly. It was a very scary experience. This, of course, happened to me **before I realized that I was a targeted individual**.
- I have experienced the **directed energy weapons on two occasions**, which is one of the most **frightening** things a person could ever encounter. I would not wish this on my **worse enemy**. In the drop of a dime, your body heats up intensely to an extremely high temperature. I literally felt a hot, tingling sensation all over my body and immediately broke out into a sweat. It made me dizzy and disoriented, and I had to stop everything that I was doing.

v. **Psychotronic Weapons: Voice of God & Image Induction Weapons (Sci Fi Made Real)**

- This technology is discussed in **Dr. Duncan's book**. You may also find videos about it on **youtube** by searching for "Dr. Robert Duncan" or "Project Soul Catcher."
- This technology sounds absolutely crazy, **BUT IT IS REAL!** Through the use of **microwave radio frequency radiation**, control panel stalkers are able to literally **induce sound, including voice, into a targets cochlea** so that they hear voices. This technology is the **linchpin** of the entire gang stalking program:
 - To the targeted individual that does **not realize they are target or that this technology exists**, they start to believe that they are having a **schizophrenic or psychotic** episode. And if they **try to explain to someone else** that they are hearing voices, then that person will, of course, reach the same conclusion.
 - In essence, the person either thinks they are crazy or other people think the person is crazy. This **works in favor of the program always remaining a secret** because any target that attempts to speak out about this will instantly be **discredited as schizophrenic**. This also **further isolates** the target from acquaintances, friends, and loved ones. **BUT PLEASE REVIEW DR. DUNCAN'S TECHNOLOGY BEFORE YOU WRITE THIS OFF AS UNBELIEVABLE OR CRAZY!!!**
- With the image induction technology, which is based on the same bio-technological research as Voice of God Weapons, control panel stalkers are able to **induce images into a target's mind** (which is typically done while the target is **sleeping**). In addition, control panel stalkers are **able to see any images originating from the target's mind**—both **actual images** (what the target is actually looking at) and **fictional images** (images that the target is thinking about from memory or imagination)

IV. Effectiveness of Voice of God Weapons for the Overall Stalking Program

- A. Just as control panel stalkers can induce sound into a target's ear, control panel stalkers **can induce sound into a street-level stalker's ear**. In this way, control panel stalkers are able to easily **alert street-level stalkers** of the presence of a target and give them **direction as to how to interact** with the target without the target ever knowing. The **target is left in a perplexed state**, wondering how the street-level stalkers even know who they are.
- B. **Fortunately, I was able to figure this out**. Unfortunately, many targets have not and probably never will, which only further exacerbates the psychological stress that they endure.

Dear Ms. Mitchell and Other Addressees:

The purpose of this letter is three-fold. First, I would like to make a sincere plea to you not to let my personal story die. Enclosed within this letter, you will find a USB flash drive containing a personal testimony from me about the financial, emotional, and psychological pain that I have endured over the course of the past few months since I discovered that I was a "targeted individual." I have literally been forced to endure a living hell. There are thousands of targeted individuals within the United States that literally suffer each and every day at the hands of our government. Personally, I have experienced significant harassment from law enforcement in every place that I have been these past few months.

Second, over the coming days and weeks, you will hear numerous people try to label me as a person with mental health issues. If you simply google "targeted individual," "gang stalking," "Freedom From Covert Harassment and Surveillance," or "Dr. Robert Duncan,"¹ you will see that what I have experienced, albeit not widely known, is very real. In addition, you can find various videos on youtube by searching under these exact same search terms. Our government is able to capitalize on this lack of knowledge among the general population to curb sentiments towards questioning the mental health of targeted individuals rather than admitting the truth—that there is a system of covert torture of ordinary, innocent citizens that is happening within our own borders. **I have not told a single person exactly what I intend to do—and only you eight people know that I intend to do anything at all**—but my goal is to garner some much-needed media attention to the plight of targeted individuals because we are a marginalized group with few financial assets. Coincidentally, that means we get ignored.

Third, enclosed within, you will also find a sample letter to congress. Please encourage as many people as you can to send a copy of this letter to congress. My hope is that if enough people take a genuine concern into the struggles of targeted individuals, then congress will have to do something to stop it once and for all—not like the false machinations of stopping it that took place in the 1970s with COINTELPRO.

I apologize for putting this responsibility on you guys, but you are people that I know and trust. I am confident that Ms. Mitchell will not allow my story to die. I sincerely hope that you will (1) keep an electronic copy of my story for yourself, (2) provide a copy for distribution to media outlets, (3) make sure that Ms. Mitchell gets a copy [although I am sending her a copy, I fear that it may be intercepted], and (4) see to it that if my story is removed from the internet—youtube, vimeo, etc.—it will be promptly re-uploaded. I know that I am asking for a lot, but please assist me with this.



Dear Representative/Senator _____:

After hearing about the story of Targeted Individual Myron May and other targeted individuals, I have accepted the challenge to do what I can to make a difference. That's why I am urging you to pass a bill or resolution to begin an investigation into the targeting of United States citizens for the types of harassment outlined in my letter below:

Although not widely known by the public, targeted individuals endure a scheme of conduct designed to drive them over the edge mentally, physically, and emotionally. This scheme is referred to among the targeted individual community as "gang stalking." Gang Stalking is a systemic form of control, which seeks to control every aspect of a Targeted Individuals life. Gang stalking takes place outside in the community. It's called gang stalking because the target is followed around and placed under surveillance.

Gang Stalking Goals

The goals of gang stalking are to (a) silence an individual, (b) drive a victim insane and possibly to the point of suicide, and (c) destroy the victim's reputation and believability—as the person will be viewed as mentally ill if they complain or report such abuse. Gang stalking may also be used to force an individual to move or leave an area.

Motivations for Gang Stalking

The motivations for gang stalking vary widely. Three of the most common are as follows:

- Being a corporate or government whistle blower (particularly if you are exposing conduct that is unbecoming of law enforcement);
- Revenge for getting away with a criminal offense;
- Knowing too much about gang stalking itself—because you become a threat to exposure

Who Are The Stalkers?

For the most part, stalkers are everyday citizens that are usually acting under some type of guise (e.g., that they are doing something positive for the community; a false accusation that the targeted individual is under investigation for a crime). Other stalkers, however, are simply paid to harass a targeted individual. Sadly, many of these gang stalkers are involved in law enforcement.

Examples of Gang Stalking Harassment

Here are some of the stalking activities that targeted individuals have to endure: slashed tires, threatening phone calls, hangup calls, verbal assaults by strangers, property damage, death threats, peeping toms, being followed on foot and by vehicle, and character assassination among family, friends, neighbors, and coworkers.

Tactics Used by Stalkers

Anchoring

A technique employed by stalkers to persuade the targeted individual that a particular group is responsible for the abuse—neighbors, racial-ethnic group, etc. The goal is to trick the targeted individual into thinking an innocent bystander is the culprit of their harassment and compel the targeted individual into verbally or physically assaulting that person.

Brighting

Brighting involves the practice of repetitive flashing of a car's high beam headlights at a targeted individual. The targeted individual is flashed an inordinate amount of times from either a tailgating, passing, or oncoming vehicle. Brighting also occurs when bright lights are flashed into a targeted individual's home windows.

Electronic Harassment

Electronic harassment is the use of technological devices to spy on or cause harm to targeted individuals (e.g., exposure to high electromagnetic fields, microwave radiation, etc.). A frequent form of harassment involves beaming a low frequency tone into a targeted individual's area, which over time causes sleep deprivation, agitation, and stress. A great deal of this research is highlighted in a book written by the pioneer of electronic harassment, Dr. Robert Duncan, which is entitled "Project Soul Catcher: Secrets of Cyber and Cybernetic Warfare Revealed." Other prominent individuals in the field include Dr. Nick Begiche, Dr. John Hall, and Dr. Terry Andersen. In addition to electronic harassment, stalkers utilize nanofibers to track targeted individuals.

Ghosting

Ghosting refers to the practice of rearranging or moving a targeted individual's personal belongings to make the targeted individual question his/her sanity (e.g., moving home furniture, lawn decorations, desk decorations, etc.).

Mimicry

Mimicry is a specialized form of harassment in which the stalkers imitate every movement made by the victim.

Mobbing

Mobbing is a term that describes intense group bullying. Several stalkers descend upon a targets area in the same time period. In these instances, gang stalkers are not as discrete because they want to make their presence known to the targeted individual.

Noise Campaign

A noise campaign is an orchestrated effort to produce stress in a targeted individual by prolonged exposure to noise (e.g., neighbors playing loud music, cars passing at rapid paces, vehicle horns blowing, technological devices to induce dogs to bark, etc.).

Sensitization

Sensitization is a psychological term referring to the forced association between a stimuli and a corresponding reaction. For example, if a targeted individual is frequently harassed by people wearing blue baseball caps or sunglasses, over time, the targeted individual will believe that anyone wearing a blue baseball cap or sunglasses is a stalker coming to harass them.

Gas-Lighting

Gas lighting refers to presentation of false information for the purpose of making victims doubt their own memory, perception, and sanity.

Hacking

Hacking generally refers to the downloading of viruses and malware as well as gaining remote access to a targeted individual's electronic devices. After gaining such access, stalkers are able to delete files, modify files, and contemporaneously interfere with a target while he or she is working.

It is my hope that you will accept the challenge as I have. Again, I strongly urge you to consider passing a bill or resolution to conduct an investigation into the harassment outlined in my letter above. Thank you for your consideration.

MY EXPERIENCES AS A TARGETED INDIVIDUAL

My deepest regret is that I did not make a more diligent effort of documenting my experiences as a targeted individual along the way; however, this document is my feeble attempt at recounting my experiences thus far. First off, to anyone that may read this document, take a brief moment to pray for my soul. What I am about to do I have deep regret for; however, I feel that my options are extremely limited. Because I am a targeted individual, everything has been taken away from me. I have literally been robbed of life through psychological, financial, and emotional hardship.

I first realized that I was a target while I was working as an Assistant District Attorney for the Third Judicial District Attorney's Office in Dona County, New Mexico. I tried going to the police about my situation. On or about September 7, 2014, I went to the Las Cruces Police Department to make a report of my experiences. The interior of the LCPD office was locked, but there was a phone in the vestibule, which dispatch answered. I informed dispatch that I wanted to make a police report, and they sent an officer out to my location. I believe the officer's name was Kenneth Davis (Caucasian male that appeared to be in his 20s). The officer took notes of my experience; however, no police report was ever made. Nevertheless, there should be a record of my phone call with Dispatch. That morning, I got invited to the gun range by my girlfriend's friend's husband, Robert Kitcey (rkitcey@gmail.com). When I met up with him later that morning at Starbucks, I informed him and another guy that was with him of the police report that I had just made. If you need to get in contact with Robert, you can contact my ex-girlfriend, Danielle Nixon [REDACTED]. I don't remember the other guy's name, but he is an engineer from Michigan (Caucasian male in his late 40s or early 50s), and his wife's name is Betty (Kenyan woman who appears to be in her early 40s, with a bald haircut).

My apartment was broken into, and my phone was tampered with. I started being followed by various individuals in unmarked cars. And on one occasion, I was followed by an individual in an LCPD sport utility vehicle cruiser. Through electronic harassment, these individuals convinced me that I was guilty of a crime. As a result, I attempted to turn myself in at the Dona Ana County Detention Center on three separate occasions. I was literally escorted to the jail by about ten cars; however, no one went inside the jail with me. Each time I attempted to turn myself in, the cars waited in the parking lot (watching me go inside the jail). But the jail informed me that they had no paperwork for me. Then, each time I left the jail after being turned away, the cars that escorted me into the jail were gone.

I continued to be followed. I informed my girlfriend, Danielle Nixon, who resides in Las Cruces [REDACTED], and my friend, Kirton, who also resides in Las Cruces [REDACTED], of these instances. Because I was an over-achiever in my position, I frequently worked late. When I was in the office alone after hours, I would consistently see individuals peeking around corners at me. As a result of this harassment, I eventually resigned from my Assistant District Attorney position and traveled to Houston, Texas to get my old job back. I met with my old boss, Alfonso Kennard, on the evening of Friday, October 10, 2014, to discuss rejoining his law firm, Kennard Law, P.C. as an Associate. On that evening, Kennard offered me my old job back at a base salary of \$50,000 per year plus 20% commissions on all settlements or judgment obtained on my cases.

After we had reached terms on that agreement, Kennard called his driver, Randy [stout, Caucasian male who appeared to be in his late 40s], to take us to another place because we had been drinking and should not have been driving. Before Randy arrived, Randy's friend Edwin arrived. It was unclear to me how Edwin could have possibly known who we were, but he approached Kennard and I at the bar and claimed that he was there to meet with Randy. When Randy arrived, we had one last drink. As we were leaving, I went to my car to retrieve my ID and wallet. I returned to find Randy and Edwin whispering to Kennard. When I returned, everyone acted very unusual toward me; it was not the same jovial conversation that had preceded this occurrence. Then, we loaded up into Randy's SUV to go to the next location. As we were driving to the next location, Kennard leaned over and asked me, "if I wanted to take a bump"—suggesting that if I wanted to take a bump of cocaine Randy or Edwin could get it for me. I vehemently assured Kennard that I did not want to take a bump. Nor had I ever taken a bump.

On Saturday, Kennard would not respond to my phone calls or text messages, which was strange because for the two days prior to that he had been very responsive. Kennard's distance did not arise until after his private discussion with Randy and Edwin. As a result of this strange behavior, I informed Kennard via text message that I may have to depose him in a lawsuit. Thereafter, Kennard called me to arrange another meeting. According to Kennard, he wanted me to discuss my re-joining the firm with his partner, Terrance Robinson. We arranged a meeting for that Monday, October 14, 2014. On Monday, we met at the A-loft, which is located at 5415 Westheimer Road next to Kennard's law office. While there, we had drinks. Kennard and Robinson had two drinks, and I had one drink. Then, we went across the street to The West End Bar &

Grille, which is located at 5320 Westheimer Road to have a meal. Shortly after we arrived, Randy showed up and suggested that we go to another restaurant down the street. Because Kennard agreed to pick up the dinner tab, I agreed to go. At the restaurant, Kennard kept insisting that I join him outside to discuss matters with him. He again brought up the conversation about me taking a bump of cocaine, and I again insisted to him that I have never taken cocaine.

After dinner, Randy dropped me off at my car, which was parked near The West End. The following day, I attempted to call Kennard, but my phone number was blocked. I attempted to call Kennard a couple of times after that, but my phone number was still blocked. While I do not have last names for Randy, the driver, or Edwin, I am certain that whatever was said in that whisper cost me my job. This situation was all a part of an elaborate scheme to put me in financial jeopardy, thereby making me more amenable to harassment and less able to fight the issue. Upset and jobless, I returned to Las Cruces to continued harassment and being followed.

On the morning when I was leaving Houston, my tire was punctured and flattened while in the driveway [REDACTED] (residence of Monica Johnson), where I was staying. When I returned to Las Cruces, I had to take my tire to On Sale Tires to have it repaired. There should be a record of that repair with On Sale Tires. Further, after returning to Las Cruces, I was subjected to a constant noise campaign designed to induce sleep deprivation in me. My neighbors played loud music, screamed, and people frequently made noise right outside my windows. Not only did this happen at night time, but this happened during the day as well. Maintenance staff, which almost never worked outside my window previously, worked and made noise right outside my window everyday.

In addition through electronic harassment, my life was constantly threatened. Fearing for my life, I decided to pack my things and move back home to Wewahitchka, FL. As I was loading my Uhaul to pack my things on October 21, 2014, my life continued to be threatened through electronic harassment. Additionally, as I was loading my Uhaul, there was a middle-aged man parked in the arroyo across the fence from my apartment complex (Quail Ridge Apartments - 251 North Roadrunner Parkway). He was driving a gray Dodge Durango 4 x 4 with a camper shell that had a Colorado License Plate, 285 YPI. This man got out of the driver-side of his truck, removed a blanket from the camper shell, and unsheathed a firearm from the blanket. Then, the most frightening thing happened. The man pointed this firearm at me, as I stood inside the trailer portion of the Uhaul truck. I jumped off the truck, ran towards my apartment, and called 911. There should be a record of this call with dispatch.

While officers were en route to my location, the man wrapped the firearm back in the blanket and put it in the right side of the camper shell. Five officers responded to the scene of Quail Ridge. These officers were acting very aggressively towards me as though I was the assailant and not the complainant-victim. Unfortunately, I was only able to get four of the officers' names: Officer Shadd; Officer Frank Gomez; Lieutenant W.C. Jackson; and Officer Guerra (who aggressively refused to give me his first name but whose badge number was L650). Officers claimed that they searched the mysterious man, but I watched this alleged search with my own eyes. They never searched his person. Nor did they even go to the right side of the vehicle, where I saw this man place the gun. They merely peeked inside the driver-side of the pickup truck, which should hardly be characterized as a search.

After talking with the man a little while longer, they came over to me and claimed that the man did not have a gun and that they had conducted a thorough search of his person and the vehicle. The continued to speak to me very aggressively and insisted that this man had driven from Colorado to Las Cruces, New Mexico to survey the land that he was on. The land that he was on is located directly behind Golden Mesa Las Cruces Independent Senior Living Community. If a survey of that property was requested, there should be documentation somewhere. I am certain that if you search, you won't find any such documentation. It does not even make sense that someone would travel all the way from Colorado to conduct such a survey, especially in light of the fact that you have to be licensed in New Mexico to conduct surveys. While it's certainly possible that this man could have been licensed in New Mexico, it is unlikely that Golden Mesa or the surface owners of the property behind Golden Mesa would not have simply hired a New Mexico-licensed surveyor. This experience, particularly the aggressive behavior of the officers, convinced me that law enforcement was very much involved in my harassment.

I am not sure what information was given to the leasing office at my apartment complex, but shortly after this incident, I received a letter on my door informing me that it was a notice to vacate my apartment. There should be a record of this notice and/or any interactions with law enforcement in the Quail Ridge leasing office. The harassment did not stop on this day with that incident. My life continued to be threatened via electronic harassment. I was literally threatened to leave Las Cruces immediately. As a result, I left several of my belongings in my apartment at Quail Ridge, which was

Apartment 1407. The leasing office should likewise have information regarding me leaving my belongings on both the interior and exterior of my apartment. One of the things that I left in my apartment was my old cell phone (a red Samsung Galaxy S3). I had gathered several license plate numbers in this phone, but because I was told through the electronic harassment that I would be left alone if I left Las Cruces and left my phone in the apartment, I did. I, however, had forwarded some of this license plate information to Altrus Campbell via text message and email. In addition, I gathered some license plate information in the iPhone that was issued to me by the Third Judicial District Attorney's Office. I sent a Preservation of Evidence email to John Willis, IT personnel with the Third Judicial District Attorney's Office, on October 21, 2014, in reference to preserving the information in that cell phone.

While traveling from Las Cruces, NM to Wewahitchka, FL, I was repeatedly tailgated and cut off by both patrol cars as well as regular cars. I was almost run off the road at one point in Kerr County, TX. Further, while I was in Kerr County, Texas, I was pulled over and officers searched my vehicle for no reason whatsoever. I did not give officers any consent to search my vehicle. Nor did they show me a warrant. They made me get out of the vehicle. They handcuffed me, and I stood in the heat with no shoes on for approximately three hours. Several officers were present, including Chief Deputy Clay Barton and Deputy Eli Garcia. There were about six more officers, but unfortunately due to the aggressiveness and hostility that the officers showed me, I was not able to get the others' information. Nevertheless, there should be Kerr County dispatch reports of the other officers that were involved. The officers held me there while a K-9 unit arrived from another county. My belongings were packed in plastic bins, and they literally opened every single plastic bin and searched it on the false claim that the K-9 had alerted to something inside the truck. The dog seemed more interested in the toy that the dog's handler was holding than anything in my Uhaul, and of course, they never found any narcotics.

I took a rest break in Houston, Texas on my way to Florida. I stopped at the residence of Monica Johnson again. While there, the noise campaign continued. In fact, they recruited the Johnson family to participate in my harassment. Marciel (pronounced Marshall) is typically a quiet and reserved person, but he was continuously speaking very loudly and screaming throughout the evening. I was sleeping on the couch in the living room. While he was in his bedroom downstairs, he had his bedroom television blaring. I believe that they were recruited to participate in my harassment based on a threat of Marshall going to jail for possession of marijuana. At about 3:00 am that morning, while I was sleeping, Monica came out of the room screaming about her daughter, Britney's car being repossessed. While it's certainly plausible that Britney's car, a red SUV, could have been repossessed, Monica went on and on about the repossession—slamming doors, dropping things, and yelling at the top of her lungs. Eventually, realizing that I was not going to get any sleep in that house, I got up and continued my journey to Florida.

Of course, the electronic and other harassment continued for the duration of my trip. I was continuously cut off and tailgated in traffic the entire way. I eventually made it to Florida. When I got to Wewahitchka, Florida (and since I have been in Florida), the harassment has continued, mainly through electronic (Voice of God – see Dr. Robert Duncan) harassment. This harassment has been very debilitating and impactful. They have recruited other individuals to participate in harassing me, including Buddy Parker (older, Caucasian male that is married to Ann Parker), Clifford Jones (son of Louise Jones), Roy Myers (who is my cousin and the brother of Michael Myers and Melody Williams), and Demetrious (not sure what his last name is, but he is the brother of Warren Bowers). There have been others that have been sent out to stalk me as well. Unfortunately, I don't know these other individuals' names. On one occasion, about two weeks ago, I was in Rich's IGA standing in front of a three-foot, front-facing section of Little Debbie snack cakes. Two gentlemen came into the store and walked directly over to me. One of the gentlemen stood inordinately close to me, very much in my personal space. When I turned to my right toward the direction of that man, the other man came up on my left, bumped me really hard and aggressively, and began a conversation with the man on my right. The man that bumped me did not say excuse me and stared at me as though he was challenging me to say something back. Although I don't know his name, I recognized the man on my left to be one of the Gulf County Sheriff's Office deputies.

In addition, I mailed Notice of Claim letters to the Dona Ana County Sheriff's Office, Las Cruces Police Department, New Mexico State Police, and Third Judicial District Attorney's Office on October 13, 2014. I am not sure what the status of those investigations are right now. But that event seemed to have been a catalyst for my electronic harassment being ratcheted up to the point of unbearable.

Over time, I have been collecting individuals' license plates that have been following me. As previously stated, some of these have already been transferred to Altrus Campbell via text message to [REDACTED] and email. The only person that I can personally identify that was stalking me in Las Cruces, NM is Elaine Lara, who resides at [REDACTED] Fe Street. On November 14, 2014, I got hit with a directed energy weapon. It is difficult to explain exactly what this feels

like. I was also stalked by a senior-level, law enforcement officer in the Dona Ana County Sheriff's Office. Unfortunately, I cannot remember his name. He is a Hispanic male that appears to be in his late 40s or early 50s, and I know that he has a teenage son that plays football. In one discussion that we had, he stated that he worked between two candidates for sheriff on the organization chart, Captain Buckingham and Kent Yalkut. His name is either Paul Nevarez or Greg Garland. I can't remember. As I previously stated, I wish that I had done a better job at keeping records of the harassment that I have endured, but this is the best that I have.

I was mailing the Notice of Claim that was addressed to Mark D'Antonio "restricted" mail so that he would have to sign for it. She covered up the restricted portion on the envelope. I asked her why she covered it. After I asked her that, she looked at me very surprised and swore that it was a mistake. Then she stamped restricted on the front of the envelope. But when the postage paid label printed, she covered the restricted stamp up, so I had to ask her again about covering up the "restricted" portion. And she stamped it again. In the midst of this craziness, I decided to take her photograph.

NOTES FOR MY PERSONAL STORY AS A TARGETED INDIVIDUAL – PART 1

I. Reason for the Video

- A. Heavy heart that I make this video
- B. Victim of **covert harassment** through **electronic harassment** and **gang stalking**
- C. Thousands of people in the United States are victims—known as targeted individuals
 - i. Google or YouTube targeted individuals and gang stalking and you'll find several victims that tell stories similar to the one you'll hear today

II. Gang Stalking Goals Generally

- A. The goal of gang stalking is to literally make a targeted individual **destitute and drive them insane**
- B. They employ various tactics to accomplish this goal
 - i. People will **follow you around in public places**—shopping, on your way to work, as sick as the may sound, I've even had people follow me into church functions
 - ii. They employ isolation tactics.
 - a) Convince your family, friends, neighbors, and coworkers through **payment, lies** (such as falsely accusing you of committing a crime) that they should keep an eye on you, and **blackmail** for people that actually are doing something wrong—that's right they actually employ criminals to help in your harassment
 - To the targeted individual that has not yet discovered they are a targeted individual, this experience is very troubling because you just notice that people are watching you and don't know why
 - There's a saying that "people will do anything for money," and if they are doing it based on a lie, then they think they're doing something positive rather than participating in debilitating a person
 - b) Eventually, due to the targeted individual's own fear and apprehension from these experiences and the lies told to the targeted individual's acquaintances, the targeted individual finds himself alone

III. Gang Stalking Methods

A. Anchoring

- i. Try to convince the targeted individual that a **particular person or group** is doing the gang stalking—neighbors, coworkers, etc.
 - a) For me, control panel stalkers **tried to convince me that my neighbors** were actually the ones stalking me, and they were very successful at this for about two

months. Because I could hear someone describing what I was doing inside my apartment, I literally thought my neighbor above me had somehow installed a video camera in my home

- This was, of course, **before I knew I was a targeted individual or what a targeted individual was**

B. Brighting

- i. This method can be one of the most irritating of all. When you are driving at night, you will encounter several cars that turn their bright lights on you when they are tailgating, in oncoming traffic, or passing you.
 - a) Now, of course, it is natural that you will encounter a vehicle now and again where the person has forgotten to click their brights off or is missing a headlight and using their brights to hide that fact, but with brighting, this **will happen about ten times in one trip** in the vehicle
- ii. Another brighting technique is when they **flash brights into the windows of your home**. Individuals will frequently pull into your driveway or near your apartment window, shining their lights directly into your home.
 - a) Again, one can expect this to happen every once in awhile by happenstance, but when brighting is being employed, it will **happen several times in one night**

C. Noise Campaign

- i. This can be just as irritating as brighting. Basically, the targeted individual is subjected to a constant bout of noise to **keep them on edge**, and more importantly, **prevent them from sleeping**. A lack of sleep, as we all know, makes a person **edgy, agitated, and full of stress**
 - a) **Loud music** by neighbors
 - b) **Cars passing by** at rapid paces and blowing their **car horns**
 - c) Neighbors **screaming and talking loudly** near your home
 - Again, others are convinced to do this based on payment, blackmail, and lies that you have done something wrong or that you're crazy
 - d) Craziest tactic involved in a noise campaign is utilization of **machine-generated sounds** (e.g., dog barks, chickens calling, duck calls, etc.)
- ii. My personal experience with a noise campaign is what made me realize that I was a targeted individual. I traveled to Houston, TX to get away from Las Cruces for awhile because I literally was starting to question my own sanity. While I was in Houston, I was staying at my friend, **Kimberly Snagg's mom's home**.
 - a) **Every ten minutes a car came flying down this residential street** making all sorts of noise and about **every 30 minutes a horn was blowing**. Having been at this house several times and knowing that only old people lived in the neighborhood, I knew that this was unusual.
 - b) What was even more puzzling was that I started hearing the **"cock-a-doodle-doo"** of

a rooster coming from one of the houses in the back. It was the exact same cock-a-doodle-doo **without any variation** to it; it was happening at **4pm in the afternoon**; and it **continued literally for hours** on end.

iii. It was this experience that made me realize that maybe there was more to my being followed than I had previously imagined

iv. Some of my other experiences with a noise campaign

a) I was staying at my friend, **Monica Johnson's home**. And I am certain that they convinced the Johnson family to participate. While I hate to spill the beans on family, Monica's husband, **Marshall, smokes marijuana**. I am convinced that they **blackmailed** them into participating in my harassment. This of course was not the first time that I had visited them. But on this occasion, everyone was being extremely noisy, and **at about 3am**, Monica came into the living room, where I was sleeping on the couch, yelling about her daughter, **Brittany's, car being repossessed**. Also, there were **three TVs** on in the house at **full blast** throughout the night.

b) In Las Cruces, my **neighbors constantly made noise**—I went a **1.5 years with no such noise**, then all of a sudden it was nonstop.

c) **One night in particular**, the neighbor above me was playing his music extremely loud, so I put **ear plugs** in. Moments after I put earplugs in, from the neighbor's apartment next to me—the headboard of my bed literally sits on her wall—I started hearing **extremely loud sex sounds**. Again, I have lived in this apartment for **1.5 years without any such noises**, but on this night, it was extremely loud.

a) The sensitization technique that was used on me was **dark sunglasses**. The goal was to make me believe that everyone wearing dark sunglasses was out to harass me. While I definitely knew that was not the case, I still **found myself looking curiously at people wearing dark sunglasses**.

G. Mobbing

- i. This refers to a stalking technique in which the target encounters **several individuals stalking them at once**. This typically happens when the target starts to realize that something more is going on or is in a frustrated state. It is **designed to scare the target**.
 - a) This particular technique has happened to me on **numerous occasions**. Because I have a pretty **low anger threshold**, typically, when I have gotten upset about my experiences, that is when I experience mobbing. Through the use of **microwave radio frequency radiation**, control panel stalkers are able to literally **induce sound, including voice, into a targets cochlea** so that they hear voices. This technology is the **linchpin** of the entire gang stalking program:

- To the targeted individual that does **not realize they are target or that this technology exists**, they start to believe that they are having a **schizophrenic or psychotic episode**. And if they **try to explain to someone else** that they are hearing voices, then that person will, of course, reach the same conclusion.
 - In essence, the person either thinks they are crazy or other people think the person is crazy. This **works in favor of the program always remaining a secret** because any target that attempts to speak out about this will instantly be **discredited as schizophrenic**. This also **further isolates** the target from acquaintances, friends, and loved ones. **BUT PLEASE REVIEW DR. DUNCAN'S TECHNOLOGY BEFORE YOU WRITE THIS OFF AS UNBELIEVABLE OR CRAZY!!!**

c) With the image induction technology, which is based on the same bio-technological research as Voice of God Weapons, control panel stalkers are able to **induce images into a target's mind** (which is typically done while the target is **sleeping**). In addition, control panel stalkers are **able to see any images originating from the target's mind**—both **actual images** (what the target is actually looking at) and **fictional images** (images that the target is thinking about from memory or imagination)

IV. Effectiveness of Voice of God Weapons for the Overall Stalking Program

- A. Just as control panel stalkers can induce sound into a target's ear, control panel stalkers **can induce sound into a street-level stalker's ear**. In this way, control panel stalkers are able to easily **alert street-level stalkers** of the presence of a target and give them **direction as to how to interact** with the target without the target ever knowing. The **target is left in a perplexed state**, wondering how the street-level stalkers even know who they are.
- B. **Fortunately, I was able to figure this out**. Unfortunately, many targets have not and probably never will, which only further exacerbates the psychological stress that they endure.
