I am involved in a TS/SCI Special Access Program (SAP) that is being run, mainly, out of the DIA, although other organizations are involved in the SAP. It initialized on September 10, 2001, my first day on the job at Parsons, a major federal contractor.

Through the SAP, I provided sole-source services to the government via an agreed upon top secret contract. The federal government has decided not to honor the contract and is delinquent. I have developed an unclassified contract that has not been signed.

I am also contesting that the federal government stole proprietary information from Buckle & Bernard Agency Developers, a federal contractor owned by Mr. Pomeroy. The information stolen included several projects and patents pending, among other types of information.

The estimated total amount of damages from the loss of intellectual property and product specs is large. If the federal government does not sign and execute the discussed contract, with the specified signatures (and make sure that the contract cannot be determined non-compliant through federal regulations), an action will be filed listing Mr. Obama, among others, as complicit conspirators to torture, cyber crimes and corruption.

I am of the same persuasion as you, Mr. Gohmert that Mr. Barack Obama is a traitor and is guilty of aiding and abetting known traitors and enemies of the state, both foreign and domestic. #### Dear Honorable Louie Gohmert:

"Whoever, owing allegiance to the United States and having knowledge of the commission of any treason against them, conceals and does not, as soon as may be, disclose and make known the same to the President or to some judge of the United States, or to the governor or to some judge or justice of a particular State, is guilty of misprision of treason and shall be fined under this title or imprisoned not more than seven years, or both."

To avoid prosecution under the referenced code, I am again warning and notifying you that we have traitors in the Federal Government, and some are receiving this letter. To assuage any concerns I have, provide me with protections and pay for services rendered, please get the contract signed and executed.
