Dear Michael Weiss and The Insider team,

Your March 8, 2026 investigation into Havana Syndrome, confirming portable pulsed microwave/RF directed-energy weapons, GRU Unit 29155 links, U.S. secret testing, matching injuries, and CIA mishandling, is a major breakthrough.

As founder of the STOPEG Foundation (Netherlands), I am in contact with many civilians worldwide experiencing identical symptoms: sudden head pressure, tinnitus, vertigo, cognitive issues, and other 24/7 attacks with no medical markers, as warned in the 1999-2000 European Parliament STOA reports on DEW as “perfect torture tools”.
